The candidates are informed to appear before the selection committee on the date specified below:

The candidate has to attend in person with following certificates in original for admission

- 1. Call letter
- 2. SSC certificate.
- 3. MBBS degree certificate.
- 4. MS/DNB Certificate.
- 5. Registration certificate of MBBS & MS/MD/DNB.
- 6. No. of attempts certificate for MBBS & MS/MD/DNB.
- 7. NOC from their employer for those who are working in Govt. / Pvt. Institutions.
- 8. Residence certificate (if studied in an educational institution outside the state of AP/Telengana).
- 9. Fees: The candidate has to bring two demand drafts (tuition fee & other fee) depends upon the course opted:

The DD shall be drawn in favour of the Director, SVIMS Tirupati in any nationalized bank.

- 10. Bond for Rs. 50,000/- is to be submitted in Rs. 100/- non-judicial stamp paper as per the proforma within 1 week, if selected.
- 11. If selected, they will be paid stipend as per the regulations.

Instructions to candidates:

- 1. No TA/DA will be paid for attending the counseling.
- 2. This call letter does not guarantee admission for the course.
- 3. If the candidate is unable to produce the original certificates as mentioned above during the counseling, he/she will not be permitted for counseling.
- 4. The attendance will be taken from 8:30 a.m to 10:00 a.m only. The candidates who attend the counseling beyond 10:00 a.m will not be considered for counseling and admission.
- 5. The selected candidates have to deposit all the original certificates on the day of the counseling and they will be returned only at the time of leaving the institution. Hence, they are advised to keep sufficient no. of xerox copies of certificates with them for future use.
- 6. There is no guarantee that all the candidates called for counseling will get the admission. All the seats will be filled-up based purely on merit following the rules and reservation in vogue.
- 7. Method of Selection: As prescribed in the Prospectus.
- 8. The decision of the selection committee in allotting the seats shall be final and binding.
- 9. The candidates who fail to submit aforesaid original certificates and fees on the day of counseling, will forfeit the right for admission.
- 10. The candidate who fail to attend the counseling on the said date, will forfeit the right for admission.
- 11. The candidate should not be continuing another course / job while attending the counseling. If so, they must bring 'No Objection Certificate' to attend for the counseling.
