- 05. The candidates have to submit the following original certificates for verification.

 - ii) MBBS degree certificates

 - iv) Certificate of internship
 - v) Attempt certificate of MBBS Degree
 - vi) MBBS Medical Council Registration Certificate
 - vii) Study & Conduct certificates of MBBS

Method of Selection:

- 04. The selection is based on viva-voce and interview by the committee.
- 05 The candidates are instructed to comply with all the instructions stipulated in the prospectus and other regulations of the University in force from time to time.

06. The selected candidate shall deposit all the original certificates and pay the fee on the date of counseling as specified below:
