01. The candidates have to report at 8.30 am in the Registration desk.
02. The candidate has to attend in person for counseling.
03. No proxy/representative is permitted under any circumstances in to the counseling hall.
04. Not attending to the counseling shall render the candidate forfeiting his/her right for admission

COUNSELING PROCEDURE :

05. The candidates have to submit the following original certificates for verification.

- i) 10th class (SSC) certificate
- ii) MBBS Degree certificate
- iii) MBBS consolidated marks memo
- iv) Certificate of internship
- v) MBBS Medical Council Registration Certificates
- vi) MBBS Study & Conduct certificates
- vii) PG degree certificate
- viii) PG degree marks memo
- ix) Attempt certificate of PG Degree
- x) PG degree Medical Council Registration Certificates
- Xi) PG Degree Study & Conduct certificates

Method of Selection:

06. The selection is based on viva-voce and interview by the committee.

07. The candidates are instructed to comply with all the instructions stipulated in the prospectus and other regulations of the University in force from time to time.

FEES:

08. The selected candidate shall deposit all the original certificates and pay the fee on the date of counseling as specified below :

* The refundable deposits (07, 08) in the table are to be paid at the time of joining.

- i) During the time of reporting for admission the candidate has to pay Rs. 15,000/- (non refundable) and submit all the original certificates and Bond as specified in prospectus. In case, the candidate wants to cancel the the amount paid will not be refunded.
- ii) Further, the candidate has to pay the caution & hostel deposits and hostel corpus fund on the date of joining.

- iii) The balance tuition fee (Rs. 80,000/-) will be deducted from their monthly stipend in instalments.
- iv) The course is full time and private practice will not be allowed.
08. In all matters relating to selection and admission, the decision of the Institute shall be final and binding on the candidate and selection cannot be questioned after admissions are closed.
09. The **selected candidate has to submit the following :**
- a) Medical fitness certificate certified by the Medical Officer, not lower than the rank of Civil Surgeon/ Professor working in a Government Institution,
 - b) The bond/s as per the proforma furnished in the prospectus (**Annexure – II**),
 - c) A copy of the PAN and Aadhar card
 - d) One set of photocopy of all the certificates.
 - e) Four passport size photos.
