The candidates are informed to appear before the selection committee on 17-09-2019 at 8:30 am in Sri Padmavathi Auditorium, OPD Block, SVIMS for counseling in connection with admission for the academic session 2019-20.

While attending the counseling, the candidate has to submit the following original certificates to the verification committee.

1. Call letter
2. Hall ticket of the entrance exam.
3. S.S.C. Marks certificates
4. B.Sc (N) Degree marks certificate of I to IV years
5. Degree provisional / original certificate.
6. GNM certificate & Post basic B.Sc. (N) certificate (those who studied 2 yr. degree course B.Sc. (N)).
7. Nursing council registration certificate.
8. Transfer certificate.
9. Migration certificate.
10. Experience certificate
11. No objection certificate (NOC) from the Regional Director/Commissioner APVVP as the case may be, for the candidates working in government service to claim the seat under Govt. service category.
12. Recently obtained caste certificate from Mee Seva in case of BC/SC/ST categories.
13. EWS Certificate.
14. Study certificate from Class IX to degree.
15. Residence certificate (Those students who have studied outside the State of Andhra Pradesh / Telangana only have to furnish the certificate for a period of 10 years prior to the qualifying examination that they have resided in the State).
16. The children / employees of TTD/SVIMS have to produce service certificate of the parent from the competent authority by including the name of the child and ID card of the employee.
17. **Fees: The candidate has to bring two demand drafts for Rs. 1,03,200/- towards tuition fee and Rs.2,000/- towards Caution Deposit in favour of the Director, SVIMS, Tirupati drawn in any nationalized bank, failing which, the seat will not allotted.**

The employees who are in Government service have to bring "No objection certificate" from the competent authority.

If the candidate fails to satisfy the above, he/she shall forfeit the seat and the same will be allotted to the next person in the order of merit.
