### Admission guidelines for MBBS course 2019-20 (NRI & NRI Sponsored Category)

- I. The student has to submit the following documents in original in the admission cell at SPMCW, Tirupati:
  - 1) Provisional admission order of Dr.NTRUHS
  - 2) NEET Hall Ticket -2019
  - 3) NEET 2019 RANKCARD

### 4) Filled in Application (provided by office)

- 5) Online undertaking/affidavit on anti-ragging.
- 6) Passport (6) and Stamp size (2) photos
- 7) Copy of Aadhar Card
- 8) S.S.C.Certificate
- 9) Inter Bi.PC Marks list (or) equivalent certificate from recognized board in India, if studied abroad
- 10) Transfer certificate.
- 11) Study certificate from 6<sup>th</sup> class to Intermediate.
- **12**) Joint affidavit to be executed by Parent & Student on Non-Judicial stamp paper worth of Rs.20/- (for proforma click here)

#### Additional documents to be submitted under NRI Category:

- 13) Recent NRI status certificate of the parent issued by the respective embassy with their seal or OCI/PIO/Permanent citizenship/ residence certificate from the competent authority
- 14) Copy of recent NRI bank account details.
- 15) Employment certificate of NRI parent. In case of self-employment, nature of business, annual income and proof thereof to be furnished and copy of the income tax returns filed for the previous financial year.
- 16) Declaration (Annexure) by the candidate and NRI Parent in Rs.20/- Non-Judicial stamp paper as per Dr.NTRUHS Proforma mentioned in their Prospectus

## II. <u>The classes will be commenced from 1.8.2019 and all the students have to report on 1<sup>st</sup> August without fail.</u>

#### III. Fees:

i) Tuition fees: US Dollars **20,000/-** or in Rupees equivalent to US Dollars as per the market rate prevailing on the day of payment by way of DD in favour of the Director, SVIMS, Tirupati (or) online transfer (Express Remittance only) to the Director, SVIMS A/c No. 62341552996, IFSC/RTGS Code: SBIN0020926 or Swift Code:SBININBBH29.

The difference of value if any shall be paid on the day of joining.

In case, t he candidate wants to cancel the admission/slide to other college within the final round of counseling, 10% of Tuition fee(+GST) will be deducted and the balance fee will be refunded.

ii) D.D. for **Rs.24,600/- (Rs.17,100/-**towards other fees, BLS Training –**Rs.2,500/-**

& Caution deposit **Rs. 5,000/-)** in favour of the Director, SVIMS, Tirupati.

#### iii) SpecialFees:

Tab with e- study material –It is mandatory for each student as a part of training. The fee will be finalized later.

- iv) Hostel deposit by way of D.D (for those willing to stay in the hostel) Rs. **10,000-00** (Rs.5,000-00 refundable and Rs.5,000/- non-refundable)
- IV. For hostel accommodation & dining facility enquire in the counter with warden/matron at the time of admission at SPMCW.
- V. The candidate has to report at SPMCW, Tirupati on or before the schedule notified by Dr NTRUHS with the above documents & fee, failing which their admission stands cancelled.

Failure to submit the original certificates and fees as mentioned above within the stipulated date as notified by Dr.NTRUHS, the seat will be cancelled automatically without any notice. The candidates will not be given any extension of time to pay the fee.
