INSTRUCTIONS TO CANDIDATES:

The candidates are informed to appear before the selection committee on 26-11-2020 at 8:30 am in Sri Padmavathi Auditorium, OPD Block, SVIMS for counselling in connection with admission for the academic year 2020-21. The attendance will be taken from 8:30 am to 10:00 am only.

While attending the counselling, the candidate has to submit the following original certificates to the verification committee.

- 1. Rank Card
- 2. Hall ticketof the entrance exam.
- 3. S.S.C. Marks certificate
- 4. B.Sc (N) Degree marks certificate of I to IV years
- 5. B.Sc (N) Degree provisional / original certificate.
- 6. GNM certificate & Post basic B.Sc. (N) certificate (those who studied 2 yr. degree course B.Sc. (N)).
- 7. Nursing council registration certificate.
- 8. Transfer certificate.
- 9. Migration certificate.
- 10. Experience certificate
- 11. No objection certificate (NOC) from the Regional Director/Commissioner APVVP as the case may be, for the candidates working in government service to claim the seat under Govt. service category.
- 12. Recently obtained caste certificate from Mee Seva in case of BC/SC/ST categories.
- 13. Study certificate from Class IX to degree.
- 14. Residence certificate (Those students who have studied outside the State of Andhra Pradesh / Telangana only have to furnish the certificate for a period of 10 years prior to the qualifying examination that they have resided in the State).
- 15. The children / employees of TTD/SVIMS have to produce service certificate of the parent from the competent authority by including the name of the child and ID card of the employee.
- 16. Fees: The candidate has to bring two demand drafts for Rs. 1,03,200/- towards tuition fee and Rs.2,000/- towards Caution Deposit in favour of the Director, SVIMS, Tirupati drawn in any nationalized bank, failing which, the seat will not allotted.
- 17. There is no guarantee that all the candidates called for counselling will get the admission. All the seats will be filled up based purely on merit following the rules and reservation in vogue.
- 18. The decision of the selection committee in allotting the seats shall be final and binding.
- 19. The candidate who fails to attend the counselling on the said date will forfeit the right for admission.
- 20. The candidates should not be continuing in another course / job while attending the counselling. If so, they must bring 'No Objection Certificate' that, the candidate will be relieved in time, to study the course, if selected.

The employees who are in Government service have to bring "No objection certificate" from the competent authority failing which they will considered under general category.

If the candidate fails to satisfy the above, he/she shall forfeit the seat and the same will be allotted to the next person in the order of merit.
