

#### 1. INTRODUCTION:

Sri Venkateswara Institute of Medical Sciences (SVIMS), Tirupati, established in the year 1993, under the aegis of Tirumala Tirupati Devasthanams, as a modern super speciality hospital. Later, it was granted the status of a University in the year 1995 by an act of A.P. state legislature vide act no.12 of 1995.

The objectives of the Institute are:

- a) to create a centre of excellence for providing medical care, education and research facilities of a high order in the field of medical sciences in the existing super-specialties and such other superspecialties as may develop in future, including continuing medical education and hospital administration.
- b) to develop patterns of teaching in postgraduate level and in super specialties so as to set a high standard of medical education.
- c) to provide training in paramedical and allied fields, particularly in relation to super-specialties.
- d) to function as a referral hospital.
- e) to provide post graduate teaching and conduct of research in the relevant disciplines of modern medicine and other allied sciences, including inter-disciplinary fields of physical and biological sciences.

The institution, spread in a 107.04 acre campus, is gradually growing into a prestigious university. Today, SVIMS has 37 super/broad speciality medical departments, three colleges and two inter-disciplinary departments and is developing into a centre of excellence for providing medical care, education and research activities of a high standard. In addition to these, SVIMS also provides training in para-medical and allied fields, particularly related to super-specialities.

The Institution is recognized by the University Grants Commission (UGC) under section 12 (B) of the UGC act, 1956, and the Medical Council of India (MCI) has granted permission and later recognition to start DM/M.Ch. super-specialty courses in Cardiology, Neurology, Nephrology, Endocrinology, Medical Oncology, Cardiothoracic Surgery, Neurosurgery, Urology, Surgical Oncology, Surgical Gastroenterology and PG Medical (MD) courses in Anesthesiology, Microbiology, Biochemistry, Emergency Medicine, Pathology, Medicine, General Surgery, Nuclear Medicine, Transfusion Medicine, Radio Diagnosis and Radiotherapy.

<u>National Institutional Ranking Frame work (NIRF) – 2020</u>: SVIMS got 30<sup>th</sup> rank in Medical category among top Higher Education Institutions in India conducted by Ministry of Human Resource Development, Govt. of India.

#### The constituent colleges are:

- A) SVIMS, Sri Padmavathi Medical College for Women (SPMCW): The college was permitted by govt. of India for admitting MBBS students with 150 annual intake w.e.f. 2014-15 academic year, and later increased to 175 w.e.f 2019-20. The admissions are carried out as per the GO. Ms No. 77, dt: 19.07.2019, HM & FW (C1) Dept., Govt. of AP. The college is one of the reputed institutions in Andhra Pradesh with good teaching faculty and infrastructure to impart teaching and training to the students. The admission process will be carried out by Dr. NTR UHS, Vijayawada.
- B) College of Nursing: The college of Nursing was established in the year 1996, with the objective of providing graduate, postgraduate teaching and for research in the relevant disciplines of modern nursing. Courses offered are B.Sc. (Nursing), M.Sc. (Nursing) and Ph.D. The college has excellent infrastructure with well-equipped laboratories, advanced teaching and learning activities. The Indian Nursing council recognized for B.Sc. (N) with intake of 100 students and M.Sc. (N) with intake of 30 students per annum. Later, the Govt. of A.P has issued G.O.Ms.No.60, dt: 27.07.2019 by Backward Class welfare (F), Dept. for implementation of 10% for Economically weaker Section (EWS) for admission into Educational Institutions for the academic year 2019-20. Now the seats for B.Sc. (N) is 110 and M.Sc. (N) is 33.
- C) College of Physiotherapy: The College of physiotherapy was established in the year 1998. The college offers graduate, postgraduate and Ph.D courses in physiotherapy, in-patient and outpatient services and special services through obesity clinic, pain clinic, paediatrics clinic, advanced physiotherapy, ergonomics & life style modification. There are 55 seats in BPT and 17 seats in MPT after implementation of 10% EWS reservation.
- **D)** Allied Health Science: The University started paramedical Diploma courses w.e.f. 1995-96 academic year for science graduates. The duration of the course was 02 years and on completion, a PG Diploma was awarded, which has got the recognition of Andhra Pradesh Paramedical Board. Later B.Sc. Paramedical courses with 03 years duration were started w.e.f. 2009-10 academic year in 08 specialities. Now, 10 specialities are running from the a.y. 2015 onwards. From 2015-16 onwards the duration of the course was changed from 3 years to 4 years. They are recognized by AP Paramedical Board.

#### The other interdisciplinary departments are:

E) Biotechnology: The Department of Biotechnology was established in 2003. It offers two courses, MSc. (Biotechnology) and PhD. The department has developed cardiomyocytes from human CD 34+ stem cells. The successful students have been absorbed in industrial organizations, who are leaders in production of drugs, vaccines, etc. The students have also been selected in various national level examinations like, Biotech Consortium India Ltd. (BCIL), Council of Scientific and Industrial Research (CSIR), Graduate Aptitude Test in Engineering (GATE), Indian Council of Medical Research (ICMR) etc. The intake of students for M.Sc. Biotechnology is 17 in each academic year after implementation of 10% EWS reservation.

- E) **Bioinformatics:** The Department of Bioinformatics established in 2003, is offering M.Sc. Bioinformatics and Ph.D. programmes. The students are selected in various National level examinations like GATE, ICMR, Bioinformatics Industrial Training Programme, New Delhi (BIITP). The successful students are absorbed in industrial organizations, and software companies. The DBT, ministry of science and technology, Govt. of India has sanctioned the Bioinformatics centre to support teaching and research work. The Bioinformatics infrastructure facility was housed in the Department of Bioinformatics. The Bioinformatics centre offers two studentships for final semester M.Sc Bioinformatics students and two traineeships for M.Sc Bioinformatics students every year. The students selected under this scheme are awarded a stipend of Rs 8,000/- per month for a period of six months. The intake of students for M.Sc. Bioinformatics is 17 in each academic year after implementation of 10% EWS reservation.
- F) Center for Advanced Research (CfAR): This is a advanced diagnostic and research facility established at SVIMS. This facility spans 36,000 sq. ft. built as G + 3 floors with potential to add 2 more floors. The programs on each of the floors are designed in keeping with the cross cutting research themes and to launch path-breaking healthcare innovations. All essential core equipments are in various stages of being commissioned. The CfAR building is dedicated to population health research, clinical trials infrastructure, data management centre, Biostatistics and Epidemiology, facilities for research projects under the theme "Infection, Inflammation and Immunity", Biobank, Regenerative Medicine, Islet cell transplantation, stem cell biology, Biotechnology and Bioinformatics. Viral Research and Diagnostic Laboratory (VRDL) in the first floor is funded by ICMR.

The existing medical college level VRDL is approved to be upgraded to state level VRDL. The VRDL is offering free investigations for around 21 different common and rare viruses prevalent in the area including COVID 19. The lab has tested more than 27,000 patient samples for various acute and chronic viral infections across the state and from neighboring states. The lab also participates in outbreak investigations. Teams comprising experts from different medical fields visit outbreak sites to identify the causative agents and send the reports to the state as well as national health authorities. The lab helps in building national data required for development of various health schemes. VRDL is identified as one of the center for four national multi centric projects (2-completed and 2-ongoing). It conducts annual training on serological and molecular methods for detection of viruses. The CfAR building is also used for research purpose to the students of Allied health Sciences.

#### i) Eligibility

The candidate should be a Registered Nurse and Registered midwife or equivalent with any State Nursing Registration Council.

- 1. The Minimum education requirements shall be passing of: B.Sc. Nursing /B.Sc. Hons. Nursing / Post Basic B.Sc. Nursing with minimum of 55% aggregate marks.
- $2. \ \ The\ candidate\ should\ have\ undergone\ training\ in\ B.Sc.\ Nursing\ /\ B.Sc.\ Hons.\ Nursing\ /\ Post\ Basic\ B.Sc.\ Nursing.$
- 3. Minimum one year of work experience after Basic B.Sc. Nursing, to be fulfilled prior to the date of commencement of M.Sc(N) programme.
- 4. Minimum one year of work experience prior or after Post Basic B.Sc. Nursing (regular stream) to be fulfilled prior to the date of commencement of M.Sc(N) programme.
- 5. Candidate shall be medically fit.
- 6. Govt. In service candidates have to enclose 'No Objection Certificate' from their employer.

#### ii) Method of Selection:

The selection is based on merit in the entrance test conducted by the University at B.Sc(N) standard. The test is conducted on 100 multiple choice questions. The duration of the examination shall be 90 minutes.

In case equal marks are secured in the entrance test, the total marks in B.Sc (N) shall be taken into consideration for fixing the inter merit of the candidates. If the entrance test marks & total marks in degree are equal, elder in age shall be preferred.

The selected candidates except Govt. In-Service at the time of admission have to submit an affidavit stating that they are not working elsewhere.

- i. Application form shall be filled up carefully by the applicant in her/his own handwriting in BLOCK LETTERS and no column shall be left blank or incomplete. Affix pass port size photos taken recently at appropriate places in the application. Defective applications will be rejected and no further intimation will be given to the applicant.
- ii. All information given in the application form shall be correct. Any false information or suppression of any factual information in the application would be a disqualification. In case, any false information is furnished or that suppression of any factual information comes to the notice during any time of the course, he/she will be liable for termination, besides other actions by the institution, as may be deemed fit
- iii. Full name of the candidate as given in the SSC Certificate shall be written in the application and all other related certificates shall also be enclosed and the address for correspondence shall be specified.

Selection of the candidate will not be final unless the original certificates are verified, found correct and the course fee is paid.
- iv. Late or incomplete applications without necessary enclosures will be rejected.
- v. The decision of the selection committee is final.

#### 8. REGION WISE RESERVATION

The candidate shall satisfy Local/ Non-local status as per G.O.P No.646 Edn. (W1) Dept. dt 10.07.1979 and Presidential order. The procedure indicated in the above G.O for selection of candidate as amended in G.O. Ms.No. 42, Higher education (EC2) Dept. dt: 18.05.2009 shall be followed.

#### 8.1 Reservation in favor of the Local candidates:

- a) Admission to 85% of the seats shall be reserved in favor of the local candidates in relation to the local area as provided in AP Educational Institutions (Regulation of Admission) order, 1974 as given in Annexure IV of G.O (P) No. 646, Edu. (W1) Department dt: 10.07.1979.
- b) 85% admissions are made in favor of the local candidates belonging to Sri Venkateswara University area as per the G.O. Ms.No. 26, Dt: 22.03.2016 of HM & FW (C1), Dept., Govt. of A.P.

#### 8.2 Local Area:

The part of the state comprising the Districts of Ananthapur, Kadapa, Kurnool, Chittoor & Nellore shall be regarded as Local area for the purpose of admission into Sri Venkateswara University area which is subject to the control of the State Govt. and is situated in that part.

#### 8.3 Local candidates:

- a) A Candidate for admission shall be regarded as local candidate in relation to a local area.
- b) If he/she studied in an Educational Institution or Educational Institutions in such local area for a period of not less than 4 consecutive academic years ending with the academic year in which he/she appeared or as the case may be first appeared in relevant qualifying examination.

or

c) Where during the whole or any part of the 4 consecutive academic years ending with the academic year in which he/she appeared or as the case may be first appeared for the relevant qualifying examination, he/she has not studied in Educational Institutions, if he/she had resided in that local area for a period of not less than 4 years immediately preceding the date of commencement of the relevant qualifying examination, in which he/she appeared or as the case may be first appeared.

or

- d) Local status certificate issued by MRO for claiming as AP local as per Circular No. 36/SPF&MC/2015-5, dated.08.08.2016.
- e) A candidate who is not regarded as a local candidate under sub-regulation (3.4.1) Above in relation to any local area shall
- f) If he/she has studied in educational institutions in the State for a period of not less than 7 consecutive academic years ending with academic year in which he/she appeared or as the case may be first appeared for the relevant qualifying examination be regarded as local candidate in relation to: Such local area where he/she has studied for the maximum period out of the said period of 7 years.

g) Where the period of his/her study in two or more local areas are equal, such local area where he/she has last studied in such equal periods.

or

h) If during the whole or any part of the seven consecutive academic years ending with academic year in which he/she appeared or as the case may be first appeared for relevant qualifying examination, he/she has not studied in the educational institution in any local area, but he/she has resided in the State during the whole of the said period of 7 years be regarded as a local candidate in relation to such local area where he/she has resided for the maximum period out of the said period of 7 years.

٥r

i) Where the period of his/her residence in two or more local areas are equal, such local area where he/she has resided last in such equal periods.

# N.B.: Relevant certificates must be attached to the application in respect of their claim, in respect of residence. The certificate should be obtained from the Revenue authorities.

#### 8.4 Unreserved Seats (15%)

The following categories are eligible for admission to the remaining 15% of Un-reserved seats:

- a. All the local candidates of S.V.U region
- b. Any candidate who is not local to S.V. region is treated as non local to S.V. University, if he/she is local to any other University in Andhra Pradesh /Telangana State.
- c. He/she resided for a total period of not less than 10 years in Andhra Pradesh/ Telangana State (excluding the periods of study outside the State). For this, the candidate shall furnish the residence certificate as per the proforma available in **Annexure-IV.**
- d. Candidates who are employees in the state, central government, public sector corporations, local bodies, universities and other similar quasi-public institutions within the state, provided their application is sent as in service candidates with employer's no objection certificate. If so, furnish the employment certificate from the competent authority mentioning the children as per the service record.
- e. Candidate who are spouses of local candidate, if so, furnish the marriage registration certificate and spouse residence /study for 10 years as documentary proof.
- f. On local & local candidates shall compete equally for the unreserved seats.

**Note:** The marks of the non-local candidates shall not be less than the marks of the last candidate admitted in the open competition among the local candidates. If seats in the Un-reserved category are not filled-up, they will be transferred to the local category.

#### 9. RESERVATION CRITERIA:

#### 9.1. Reservations for Schedule Castes (SC) and Schedule Tribes (ST)

- a) Out of the seats available for admission by the University, 15% seats shall be reserved for candidates belonging to SC, 6% of seats shall be reserved for candidates belonging to Scheduled Tribes in all the courses.
- b) In the event that if any seats reserved for S.T. not being filled up, they will be thrown open to the candidates belonging to the Scheduled Castes and vice-versa.
- c) In the event of the candidates from the SC and ST are not being available, these seats shall be allotted to the candidates under open competition.

#### 9.2 Reservation for Backward Classes:

- a) 29% of the available seats for admission in the University for various courses shall be reserved for candidates belonging to Backward Classes as follows: BC-A -7%, BC-B-10%, BC-C-1%, BC-D-7% & BC-E\*-4% as per the G.O.Ms.No.1793, Education, dt.23.09.1970 and G.O.Ms.No.23, Backward Classes Welfare (C2), dated. 07-07-2007 and G.O.Ms.No.231, Health Medical and Family Welfare (E1) Department, dated 11-07-2007.
- \* Subject to further orders of the Government of A.P. / High Court.
- b) If qualified candidates belonging to Back Ward Class of particular group are not available, the left over seats can be adjusted for the candidates of next group. If qualified candidates belonging to Back Ward Classes are not available to fill up the 29% seats reserved for them, the left over seats shall be treated as Open Competition seats and shall be filled up with candidates by merit.

c) The Scheduled Castes, Scheduled Tribes and Backward classes sub categories belonging to the State of Andhra Pradesh only shall be considered as specified by the Govt. of A.P from time to time.

#### 9.3 Economically Weaker Section (EWS) category (10%):

Government of Andhra Pradesh have issued G.O. Ms.No.60 Backward Classes Welfare (F) Department, dated.27.07.2019 to follow the guidelines issued by Government of India with regard to implementation of 10% reservation to the Economically Weaker Sections for admission into the Educational Institutions

As per the Gazette of India, Extraordinary Part II - Section - I Published by Ministry of Law and Justice, New Delhi, the 12<sup>th</sup> January, 2019.

Note: EWS quota will be implemented as per Govt. G.O.

#### 9.4 Kashmiri Migrants and Kashmiri pundit category (5%):

Government of India, Ministry of Human Resource Development, Economic Administration Division have issued F.No. 3-4/2017-NER, dated 5-11-2019 with regard to implementation of 5% quota to the wards of Kashmiri Migrants and Kashmiri pundits / Kashmiri Hindu families (non migrants) living in Kashmiri valley for admission in higher educational institution.

Note: Subject to receipt of applications from Kashmiri Pundits

#### 9.5 Social Status Certificate:

- a) The candidates belonging to Scheduled Castes, Scheduled Tribes and Backward Classes shall furnish a certificate in the prescribed proforma in support of their claims. The social status of Schedule Castes, Scheduled Tribes and Backward Classes candidates shall be Scrutinized in terms of G.O.M.s.No.58, SW (J) Dept. Dt. 12-05-1997. The candidates are informed that they will be not be considered for the caste claimed by them without the prescribed permanent caste certificate issued by the competent authority.
- b) No candidate seeking reservation for admission under the above categories be allowed to participate in the Counseling for admission unless he produces the Integrated Community Certificate prescribed by the Government and issued by the Revenue Authorities in the Government (Vide G.O.Ms.No. 58, Social Welfare (J) Department, dated. 12-05-1997).

Note: The Social Reservation provided for BC's SCs, ST's in the ratio of 29%,15% and 6% respectively shall be vertical reservations.

#### 9.6 Reservation for Special Categories:

- i. **TTD/SVIMS:**10% of the seats in all the courses are reserved for the children & employees of the TTD/SVIMS as per the Executive Board Meeting resolution of SVIMS, dt:29.04.1997 and 26<sup>th</sup> Academic Senate Meeting of SVIMS, dt:08.04.2009. In the event of non-availability of children of TTD/SVIMS employees, the employees are also eligible under second priority. The Employee shall enclose recently obtained service certificate from the competent authority including the name of the candidate. Proforma of the service certificate is provided as **Annexure-V**.
- ii. M.Sc. (Nursing) course: 20% of the seats are reserved in M.Sc.(N) for in service candidates to study on deputation, Vide Ref. G.O.Ms.No.282, dt:22/07/2008 of Health, Medical & Family Welfare (M1) Dept.

**Note:** Any other orders issued by the Govt. of .AP. before the counseling schedule will also be adopted.

#### 10. COUNSELLING:

#### 10.1. Counselling for M.Sc. Nursing / MPT courses:

The minimum percentage of marks shall be obtained in the entrance test as mentioned below.

Open category - 40%
BC category - 35%
SC/ST category - 30%

a. No request for re totaling or revaluation or personal identification of the answer scripts of the entrance test shall be entertained for M.Sc Nursing.

- b. The qualified candidates in the entrance test will be called for counseling and also the merit list will be placed in the institute's website. Non receipt of call letter by any individual candidate will not vitiate the selection process. If their name is found in the list of candidates called for counseling, they can attend with all the original certificates and fees for the counseling.
- c. The date of counselling will be intimated to the eligible candidates and will be placed in the institute's website.
- d. In case of any grievance, the decision of the Director-cum-VC, SVIMS shall be final and binding.
- e. Second and Third counseling schedule for vacancies will be notified in the website. No individual communication will be sent. The candidates have to visit the website and attend for the counseling.

# 10.2 Counselling for M.Sc BT/BI, M.Sc. Echocardiography & Cardiac Catheterization Intervention Technology / Dialysis Technology courses and PG Diploma in Medical Record Science

- a. All the candidates appeared for the Entrance Exam (SVIMS PG CET) conducted by SVIMS will be awarded Ranking.
- b. The Ranks will be awarded based on the combined merit in the qualifying examination (Degree) and Marks secured in the Entrance Test conducted by the University (SVIMS PG CET) in the ratio of 80:20.
- c. No request for re totaling or revaluation or personal identification of the answer scripts of the entrance test shall be entertained.
- d. The counseling will be held as per the schedule notified in the Prospectus.
- e. The merit list will be placed in the institute's website. Non receipt of call letter by any individual candidate will not vitiate the selection process. If their name is found in the list of candidates called for counseling, they can attend with all the original certificates and fees for the counseling and receive duplicate call letter in the Counseling Hall.
- f. In case of any grievance, the decision of the Director-cum-VC, SVIMS shall be final and binding.
- g. Second and Third counseling schedule for vacancies will be notified in the website. No individual communication will be sent. The candidates have to visit the website and attend for the counseling.

#### 10.3 Counselling for Post Basic Diploma in Nursing

The candidates shall have passed the qualifying examination and admission is based on the following:

- a. The merit list of the candidates for each group of courses will be prepared separately. The percentage of marks shall be calculated up to two decimal places
- b. The qualified candidates in merit order called for counseling will be sent call letter and also the merit list will be placed in the institute's website. Non receipt of call letter by any individual candidate will not vitiate the selection process. If their name is found in the list of candidates called for counseling, they can attend with all the original certificates and fees for the counseling.
- c. Second and Third counseling schedule for vacancies will be notified in the website.
- d. No individual communication will be sent. The candidates have to visit the website and attend for the counseling.
- e. In case of any grievance, the decision of the Director-cum-VC, SVIMS shall be final and binding.

#### 11. DATE OF JOINING:

The selected candidates must report to the Principal/Co-ordinator / HoD's concerned and join the course on the date prescribed in the provisional admission order and notified in the prospectus. Those who do not report within 10 days from the commencement of the course as notified are liable for cancellation of admission without further notice.

(a) Regular ExamSep/Oct(b) Supplementary examinationFeb/March

#### 13.CENTRAL FACILITIES:

#### **13.1. LIBRARY:**

There is a well established library with a collection of 11638 books with subscription for 150 print journals (81 Foreign and 69 Indian). It has a back volume journal collection of 6865 dating back to 1993. It is having e-library facility with 25 nodes for browsing internet for the use of faculty, P.G. and U.G. students. Library is kept open for 363 days in a year except on January, 26<sup>th</sup> and August 15<sup>th</sup> and functions 16 hours a day i.e. 8.00 A.M. to 12.00 Midnight. During festival holidays and Sundays, library is kept open from 10.00 A.M to 5.00 P.M. All the library services are automated by adopting KOHA library automation software.

The National medical Library, New Delhi providing membership in ERMED consortium to access 232+ e-journals with back issues.

**The National Cancer Grid**: Tata Memorial Hospital, Mumbai providing free access to 'Clinical key' (Elsevier) and some OVD SP journals (Elsevier 117 E-Journals : 87 E- Books, Wolter Kluwer E-Journals 16 and one e-book).

#### **13.2. HOSTELS:**

Due to COVID-19 Pandemic Hostel facility will be provided strictly basing on the availability as per COVID-19 guidelines.

#### 14.GENERAL INSTRUCTIONS:

- i. Candidates are advised to send their application form(s) preferably by registered post. The institute takes no responsibility for any delay in the receipt or loss of application in transit.
- ii. Employees of state or central govt. or of any public sector undertaking of state or central govt. shall send their applications through their employer. However, the advance copy of the application (complete in all respects) may be sent to avoid delay. In case, the application is not received through the employer before the date, "No objection certificate" from the employer shall be produced at the time of entrance test / counseling failing which the candidate will not be allowed.
- iii. Candidates called for entrance test and counseling will have to make their own arrangements. No TA/DA will be paid by the institution.
- iv. The decision of the Head of the institute shall be final in all the matters of selection and admission to various courses and no appeal shall be entertained on this subject.
- v. All courses are conducted on full time basis. Private practice in any form is prohibited. The candidates are strictly not permitted to undertake any other full time, part time or correspondence courses.

- vi. All candidates admitted to the institute shall maintain good conduct, carry out assignments, attend their classes/training regularly and abide by the regulations of the institute.
- vii. Selected candidates have to submit migration certificate from the university from which they have passed the last qualifying examination, at the time of joining the institute.
- viii. Eligible candidates for M.Sc., MPT and M.Sc (N) entrance tests will be sent hall tickets. Those who do not receive the same and their name be found in the list of candidates eligible for entrance test may contact the examination section through mail/phone for duplicate hall ticket.
- ix. Any changes in date, time, venue and / or schedule of the entrance tests, counseling will be announced on our website and via print media. No individual intimation will be given to the candidates.
- x. The candidates are requested to keep themselves updated by visiting the university website regularly from time to time or keeping in touch with the academic/examination section of SVIMS.
- xi. The rules and regulations in this prospectus are subject to change in accordance with the decision of the institute from time to time.
- **xii. INSERVICE CANDIDATES:** The employees who are in the Govt. service have to furnish 'No objection certificate (NOC)' from the competent authority along with the application. Upon selection shall submit relieving order from their parent institution and report for joining as on the date of commencement of the course.

#### xiii. MEDICAL CONDITIONS AFFECTING ADMISSION:

Admission to the programme for the year is subject to being found medically fit by the medical board of SVIMS.

#### **WARNING:**

In case any candidate is found to have submitted false information or certificate or is found to have withheld or concealed any information, he/she shall be debarred from continuing the course and shall face such appropriate action initiated against him/her by the Head of the Institute.

#### 14.1. Discontinuation & Refund of Fees:

The admitted students, shall submit a request to the Registrar endorsed by the parent with valid reason forwarded by the respective head of the department. The discontinuation will be permitted and fees paid will be refunded by following due procedure as per the schedule.

- 1.80% of tution fees before commencement of the academic programme.
- 2.70% of tution fees  $-1^{st}$  to  $15^{th}$  day after commencement of the programme.
- 3.60% of tution fees 16<sup>th</sup> to 30<sup>th</sup> day after commencement of the programme.
- 4. No refund Beyond 30<sup>th</sup> day after commencement of the programme.
- 5. After closure of admission, the student will not be permitted to discontinue the studies unless they refund the stipend amount received by him/her (if any), from the institute.
- + 18% GST will be collected for Fee collected from students for cancellation / Discontinuation of the course.

#### 14.2. Discipline among Students:

All powers relating to discipline and disciplinary action in relation to the students of the University are vested with the Director cum Vice Chancellor. He may delegate all or any of his powers a she deems proper to any of the officers of the University.

The students shall maintain strict discipline during the period of study/training programme in terms of conduct rules of the institute. The candidates shall not resort to any strikes during the period of their study. Use of alcohol, banned drugs, drug trafficking and eve teasing and any other criminal offences, are strictly prohibited in the campus and students found indulging in such activities will be subjected to strict disciplinary action as per the law. Indulging in any criminal activity within or outside the University and any physical violence against colleagues/ students / residents will attract stern disciplinary action including rustication.

The students are not permitted to approach the print or electronic media for redressal of their grievances, this amount to indiscipline. They are not permitted to approach legal authorities / INC / MCI / Govt. etc., without prior permission from the institution. In case of violation of the conduct rules, the admission of the candidate is liable for cancellation apart from disciplinary action by the institute.

A Committee is constituted by the university to combat the menace of violence against women and sexual harassment in the campus as per the Hon'ble Supreme Court of India guidelines. Suitable action will be taken by the committee based on their report against the student who is involved in such activity.

Malpractice is an offence. Students involved in malpractice (use of unfair means) in University examinations will be punished as per SVIMS University regulations.

### 14.3. Ban on ragging in the campus:

As per the orders of the "Hon'ble Supreme Court of India" if any incident of ragging comes to the notice of the authority of the University, he/she who has indulged in such incident shall be given liberty to explain and if his/her explanation is not satisfactory, the authority would expel him/her from the University besides making entry in his certificates to that effect. Apart from the above, the students are liable for a fine up to Rs.50,000/-, rigorous imprisonment up to three years (by court of law), and other punishments as per the Act.No.26 of 1997, dated 21-08-1997 of State of Andhra Pradesh.

The disciplinary committee constituted by the university shall examine all the disciplinary and related issues pertaining to the students. The misconduct /indiscipline related cases shall be brought to the notice of the Dean. Based on the gravity of the case, the committee shall make appropriate recommendations for further action.

#### 14.4. Games and Sports:

The institute is promoting the sports and games culture among the student community by organizing coaching camps in various disciplines for the University teams. The University is member of Association of Indian universities (AIU) and students participate in Inter University Zonal and All India level Tournaments regularly. Further, the University organizes annual competitions to inspire the student community to involve in sports and games to improve their health status.

#### 14.5. Hostel Accommodation:

- i. Shared accommodation will be provided to the candidates on rent fixed as per rules of the institute subject to availability. They will have to necessarily stay in the accommodation, if provided by the institute.
- ii. The students are required to vacate the hostel accommodation within seven days of the completion of their course failing which Rs.100/- and Rs.200/- per day will be levied for bachelor and married hosteller respectively as penal rent for unauthorized occupancy of hostel accommodation. Under such circumstances, the room will be vacated/evicted by the hostel authority / security staff during the unauthorized stay.
- iii. The students will be responsible for proper upkeep of the furniture and other fixtures of the room. In case of damage/loss, a penalty would be imposed as assessed by the wardens of the hostels.
- iv. No electrical/civil alternation in the room is allowed.
- v. Use of air conditioner/ heaters and other electrical appliances consuming high electrical energy is not permitted in the hostel.
- vi. Hostel facility is available for the candidates who satisfy the following:
  - a. Payment of caution deposit of Rs. 5,000/- (refundable) and hostel establishment fund (Corpus fund) of Rs. 5,000/- (Non-refundable) to be paid on the day of allotment of hostel accommodation.
  - b. The mess charges shall be borne by the students apart from the hostel establishment charges as applicable. At the time of allotment of hostel, the candidate has to pay 01 year mess charges & establishment

Charges in advance.

#### 14.6. SCHOLARSHIP:

The students who belong to SC/ST/BC/PWD/EBC/EWS minority are eligible to get the scholarship from the respective welfare authorities of the Govt. of A.P. The eligibility of the candidate for reimbursement of fee is decided by the social welfare officer after verifying the original documents like caste, ration card, aadhar card, income certificate etc., on the day of the counseling. The difference of tuition fee is to be paid by the student in each academic year. In the event of submitting wrong declaration and documents, both the student and parent are liable for legal action.

#### 15. TRAINING:

Sri Venkateswara Institute of Medical Sciences (SVIMS), Tirupati imparts training through attached super specialty hospital & Sri Padmavathi Medical College for Women Hospital.

Presently, both hospitals together have 940 beds providing services to the patients. For the year 2019, 5,50,635 out patients visited, 46,054 in-patients were admitted and 14,218 patients under vent surgeries in both the hospitals. The Institute performed 23,57,754 investigations.

SVIMS ensures that teaching methods employed, facilities and content of the programs are in line with the latest innovations with a strong science base. The Institute promotes teaching and training through seminars, didactic lectures and wide range of clinical and laboratory experiences, independent thinking and relevant research.

The students are provided hands on training in the State-of-Art equipments available in the Institute under the supervision of senior technologists and faculty. They are not permitted to handle the equipment and patients independently. In the event of causing damage to the equipment or accessories or misbehaving with the patients will lead to stern disciplinary action apart from recovery of the damage caused.

#### 16. COURSE MAXIMUM PERIOD OF STUDY:

Maximum period of the study of the course (duration of completion of the course):

The maximum total study period (defined as the period from enrolment into the course till passing of all examinations including final) shall be twice the minimum / normal study period of that particular course. The period of internship if any, shall be excluded from this duration of course.

#### **17. MEDALS:**

The following medals are instituted to the best outgoing students in the following courses.

- i) Late Dr. P. Subramanyam, IAS Memorial medal for the best outgoing student in M.Sc Life Sciences (BT & BI) courses.
- ii) Faculty, College of Physiotherapy medal for the best outgoing student in MPT course.
- iii) Komal Reddy Foundation Trust Medal for the best outgoing student in M.Sc. Nursing.

Note: The confirmation of the admission is subject to the outcome of any litigation pending before any court of law in the Republic of India.
