Note: (i) 5% of seats shall be reserved for differently abled candidates as per the Gazette of India, notified by Ministry of Social Justice and Empowerment (Department of Empowerment of Persons with Disabilities (Divyangjan)) New Delhi, dt: 15th June, 2017, (ii) The candidate seeking the benefit of reservation shall apply under this category and upload a valid disability certificate issued by the competent authority. (iii) The guidelines of Govt. of India and regulations of Medical Council of India shall be observed in making admissions of persons with disabilities (Physically Handicapped) candidates. (iv) The disability certificate shall be obtained within 6 months prior to last date for submission of application. (v) The candidates under PWD/ PH category shall undergo medical examination on the day of counselling for physical examination by the medical board constituted by the institute, to examine and confirm the extent of the disability as per Govt. guidelines. They will also verify the original disability certificates. (vi) The decision of the SVIMS Medical Board on physical disability status shall be final.
