Admission guidelines for MBBS students of the AY 2021-22 (Merit Category)

- I. The student has to submit the following documents in original at the verificationcounter:
 - 1) Provisional admission order of Dr.NTRUHS
 - 2) NEET Hall Ticket -2021
 - 3) NEET 2021 RANKCARD
 - 4) Filled in Application (provided byoffice)
 - 5) S.S.C. or its equivalent examination certificate showing the date ofbirth.
 - 6) Intermediate Bi.P.C Marks list.
 - 7) Transfercertificate.
 - 8) Study certificate from 6th class to intermediate (or) Residence certificate of the candidate /parents
 - 9) Copy of the Aadhar Card
 - 10) Spl. Category certificate NCC/CAP/EWS/PHC etc (ifapplicable).
 - 11) Mee Seva caste certificate. (For BC, SC, ST categoriesonly)
 - 12) Online undertaking/affidavit onanti-ragging.*
 - 13) Passport size photographs -4.
 - 14) Stamp size photographs -2.
 - 15) Filled in declaration form for eligible scholarship holders only. (provided by theoffice)
 - 16) Copy of White ration card / Income certificate of the parent (For eligible scholarshipholders)
 - 17) Joint affidavit to be executed by Parent & Student on Non-Judicial stamp paper worth of Rs.20/-
- II. Asper MCI/NMC Schedule, the classes will be commenced and hence, the students are informed to join the college as per the schedule and they are advised to come with all the required luggage. The hostel accommodation will be provided on the day of reporting.
- III. There will be physical and clinical evaluation on the day of reporting at 8:30 a.m before the medical board at SPMC(W) Hospital building and certain tests will be conducted to take care of holistic health ofstudents
- IV. Payment of fee by way of DD in the name of Director, SVIMS, Tirupati asfollows.
- V. i) Tuition & Other Fees:

Two separate demand drafts for Rs.8,000 (non refundable) & Rs. 69,100/- (refundable). If candidate wants to cancel admission / slide to other college within the time schedule, except Rs.8,000/- the remaining fees will be refunded and also as per latest GST guidelines, the candidate has to pay GST@ 18% i.e Rs.1,440/-.

iv) Hostel deposit (for those staying in the hostel)

- v) For hostel accommodation & dining facility enquire in the counterwith warden/matron and follow the hostel norms.
- VI. Failure to submit the original certificates and fees as mentioned above within the stipulated date as notified by Dr.NTRUHS, the seat will be cancelled automatically without any notice. The candidates will not be given any extension of time to pay thefee.
- VII. Aftersubmittingallthedocuments, payment of all fees, the admission order will be issued which has to be shown to the HODs of Anatomy, Physiology and Biochemistry on the day of reporting for attending classes.
