**Venue: Committee Hall, SVIMS**

01. The candidates have to report at 9.30 am at the Registration desk.
02. The candidate has to attend in person for counselling.
03. No proxy/representative is permitted under any circumstances in to the counselling hall.
04. Not attending to the counselling shall render the candidate forfeit his/her right for admission

**COUNSELING PROCEDURE :**

05. The candidates have to submit the following original certificates for verification.
  - i) 10th class (SSC) certificate
  - ii) MBBS/BDS & PG Degree certificate
  - iii) MBBS/BDS & PG consolidated marks memo
  - iv) Internship Certificate
  - v) MBBS/BDS & PG Medical Council Registration Certificates
  - vi) MBBS/BDS & PG Study & Conduct certificates
  - vii) Certificate of Social Status (ST/SC/BC category)

**Method of Selection:**

06. The selection is based on viva-voce and academic performance by the candidate.
07. The candidates are instructed to comply with all the instructions stipulated in the prospectus and other regulations of the University in force from time to time.

**FEES:**

08. The selected candidate has to pay the fee on the date of counselling as specified below:
