01. The candidates have to report at 9.30 am at the Registration desk.
02. The candidate has to attend in person for counseling.
03. No proxy/representative is permitted under any circumstances in to the counseling hall.
04. Not attending to the counselling shall render the candidate forfeit his/her right for admission

COUNSELING PROCEDURE :

05. The candidates have to submit the following original certificates for verification.
 - i) 10th class (SSC) certificate
 - ii) MBBS degree certificates
 - iii) MBBS consolidated marks memo
 - iv) Certificate of internship
 - v) MBBS Medical Council Registration Certificate
 - vi) Study & Conduct certificates of MBBS
 - vii) Certificate of Social status (ST/SC/BC category)

Method of Selection:

06. The selection is based on viva-voce and academic performance by the candidate.
07. The candidates are instructed to comply with all the instructions stipulated in the prospectus and other regulations of the University in force from time to time.

FEES :

08. The selected candidate has to pay the fee on the date of counselling as specified below :

- i) During the time of reporting for counselling the candidate has to pay Rs. 30,700/- & submit all the original certificates mentioned above and Bond as specified in regulations.
 - ii) In case, the candidate wants to cancel the admission the amount paid will not be refunded.
 - iii) Further, the candidate has to pay the caution, hostel deposit and hostel corpus fund on the date of joining.
09. The course is full time and private practice will not be allowed.
10. In all matters relating to selection and admission, the decision of the Institute shall be final and binding on the candidate and selection cannot be questioned after admissions are closed.
11. **The selected candidate has to submit the following:**
- a) Medical fitness certificate certified by the Medical Officer, not lower than the rank of Civil Surgeon/ Professor working in a Government Institution.
 - b) The bond as per the proforma furnished in the prospectus (*Annexure – I*)
 - c) A copy of the PAN and Aadhar card.
 - d) Originals and one set of photocopy of all the certificates.
 - e) Four passport size photos.
