I. The student has to submit the following documents in original at the verification counter:

- 1) Provisional admission order from MCC, DGHS, Govt. of India
- 2) NEET Hall Ticket –2023
- 3) NEET 2023 RANK CARD
- 4) Application form
- 5) S.S.C. or its equivalent examination showing the date of birth.
- 6) Intermediate Bi.PC Marks list.
- 7) Transfer certificate.
- 8) Study certificate from 6th class to intermediate (or) Residence certificate of the candidate / parents
- 9) Migration Certificate
- 10) Copy of the Aadhar Card
- 11) Valid EWS Certificate as per MCC format (if applicable)
- 12) Valid Special Category certificate - NCC/CAP/PHC etc (if applicable).
- 13) Valid Caste certificate as per MCC format (For OBC, SC, ST categories only)
- 14) Online undertaking/affidavit on anti-ragging.*
- 15) Joint affidavit to be executed by Parent & Student on Non-Judicial stamp paper worth of Rs.20/-
- 16) Passport size photographs –4 & Stamp size photographs –2

II. Fees Payment through online/ SBI Collect only:

i) University fee	: Rs.10,500/-

iv) College Caution deposit	: Rs. 5,000/- (Refundable)
v) BLS Training fee	: Rs. 3,200/-
Total	: Rs.95,800/-
vi) For Hostel Corpus fund	: Rs. 5,000/- (Non-refundable)
vii) Hostel Caution deposit	: Rs. 5,000/- (Refundable)

For hostel accommodation enquire in the counter with warden/matron and follow the hostel norms.

Payment shall be through online transfer/ SBI Collect to the Director, SVIMS A/c No. 52089535266, IFSC: SBIN0020926. The parents are advised to bring bank cheque book.

If candidate wants to cancel admission / slide to other college within the time schedule, In case, the candidate wants to cancel the admission/slide to other college within the final round of counseling, the fee will be refunded after deducting Rs.8000/- of Tuition fee + GST @ 18% on Rs.8000/-

III. The candidate has to report on or before the date specified by MCC, DGHS, Govt. of India with the above documents, failing which their admission stands cancelled.

IV. The classes will be commenced As per NMC Schedule and hence, the students are informed to join the college as per the schedule and they are advised to come with all the required luggage. The hostel accommodation will be provided on the day of reporting.

V. After submitting all the documents, payment of all fees the admission order will be issued which is to be shown to the Heads of the departments (Anatomy, Physiology and Biochemistry) for attending classes.
