#### I. INTRODUCTION:

Sri Venkateswara Institute of Medical Sciences (SVIMS), Tirupati, established in the year 1993, under the aegis of Tirumala Tirupati Devasthanams, as a modern super specialty hospital, became a university in the year 1995 by an act of A.P. state legislature vide act no.12 of 1995. The objectives of the institute are:

- a) to create a centre of excellence for providing medical care, education and research facilities of a high order in the field of medical sciences in the existing super-specialties and such other super-specialties as may develop in future, including continuing medical education and hospital administration.
- b) To develop patterns of teaching in undergraduate & postgraduate level and in super specialties so as to set a high standard of medical education.
- c) To provide for training in paramedical and allied fields, particularly in relation to superspecialties.
- d) To function as a referral hospital.
- e) To provide for post graduate teaching and conduct of research in the relevant disciplines of modern medicine and other allied sciences, including inter-disciplinary fields of physical and biological sciences.

The institution, spread in a 107.04 acre campus, has 38 super/broad specialty medical departments, three constituent colleges and is a centre of excellence providing medical care, education and research activities of a high standard in the field of medical and other allied sciences. SVIMS also provides training in Para-medical and allied fields.

The Institution is recognized by the University Grants Commission (UGC) under section 12 (B) of the UGC act, 1956, and Medical Council of India (MCI) has granted permission and later recognition to start DM/M.Ch. super-specialty courses in Cardiology, Neurology, Nephrology, Endocrinology, Medical Oncology, Cardiothoracic Surgery, Neurosurgery, Urology, Surgical Oncology, Surgical Gastroenterology and PG Medical (MD) courses in Anaesthesiology, Emergency Medicine, Microbiology, Nuclear Medicine, Biochemistry, Pathology, Medicine, Immuno Haematology & Blood Transfusion, Radio Diagnosis and Radiotherapy. Sri Padmavathi Medical College for Women was started from 2014-2015 and the MBBS course is recognized by MCI(NMC) vide Endst. No. MCI-34(41)(R-6)/2018-Med./187199 dated 13-03-2019.

#### The constituent colleges are:

- l) **SVIMS-Sri Padmavathi Medical College for Women (SPMCW)**: The college was permitted by Govt. of India for admitting MBBS students with 150 annual intake w.e.f. 2014-15 academic year and is recognized by the Govt. of India vide notification [No.U.12012/109/2019-ME.I (FTS.3205037)] dated 01-04-2019. The intake is enhanced by 25 EWS seats i.e. from 150 to 175 w.e.f. 2019-20.
- 2) College of Nursing: The college of Nursing was established in the year 1996, with the objective of providing graduate, postgraduate teaching and for research in the relevant disciplines of modern nursing. The courses offered are B.Sc. (Nursing) with 110 seats, M.Sc. (Nursing) with 33 seats including EWS and Ph.D.
- 3) College of Physiotherapy: The College of physiotherapy was established in the year 1998. The college offers BPT, MPT & Ph.D. courses in physiotherapy, in-patient and outpatient services and special services through obesity clinic, pain clinic, paediatrics clinic, advanced physiotherapy, ergonomics & life style modification. There are 55 seats in BPT and 27 seats in MPT after implementation of 10% EWS.

Allied Health Sciences: The University started paramedical Diploma courses w.e.f. 1995-96 academic year for science graduates. The duration of the course was 02 years and on completion, a PG Diploma was awarded, which has got the recognition of Andhra Pradesh Paramedical Board. Later B.Sc. Paramedical courses with 03 years duration were started w.e.f. 2009-10 academic year in 08 specialities. Now, 10 specialities are running from the a.y. 2015 onwards. From 2015-16 onwards the duration of the course was changed from 3 years to 4 years. The courses are recognized by AP Paramedical Board.

#### The other interdisciplinary departments are;

- Biotechnology: The department of Biotechnology, established in 2003, is offering M.Sc. Biotechnology with intake of 17 (including EWS) students per annum and Ph.D. programmes. The successful students are absorbed in industrial organizations, who are leaders in production of drugs, vaccines etc. The students have also been selected in various national level examinations like CSIR, GATE, ICMR, BCIL (biotechnology consortium India Ltd., New Delhi).
- Bioinformatics: The Department of Bioinformatics, established in 2003, is offering M.Sc. Bioinformatics with intake of 17 (including EWS) students per annum and Ph.D. programmes. The students are selected in various National level examinations like GATE, ICMR, Bioinformatics Industrial Training Programme, New Delhi (BIITP). The successful students are absorbed in industrial organizations, and software companies. The DBT, ministry of science and technology, Govt. of India has sanctioned the Bioinformatics centre to support teaching and research work. The Bioinformatics infrastructure facility was housed in the Department of Bioinformatics. The Bioinformatics centre offers two studentships for final semester M.Sc Bioinformatics students and two traineeships for M.Sc Bioinformatics students every year. The students selected under this scheme are awarded a stipend of Rs 8,000/- per month for a period of six months.

#### MBBS COURSE

#### I. Distribution of seats (Total 175):

- 1. **All India Quota :**15% seats (26) are filled by the Medical Counseling committee (MCC), DGHS, Govt. of India. For details of counseling schedule refer to MCC website : <a href="https://www.mcc.nic.in">www.mcc.nic.in</a>)

<u>Note:</u> The admissions are not conducted directly by SVIMS University for any of the MBBS seats in the above categories in SVIMS-SPMCW.

### II. ELIGIBILITY FOR ADMISSION OF NRI CATEGORY: As per G.O Ms. No. 129, HM & FW (C1) Dept., dated 10-06-2022.

- 1. The general eligibility conditions as notified by Dr YSRUHS shall be followed.
- 2. The women candidates are only eligible from origin of INDIA.
- 3. Additionally the eligibility condition for NRI category shall be satisfied as detailed below;
- (i) Nationality and Domicile: The candidate should be Indian National or Person of India Origin (PIO) / Overseas Citizen of India (OCI) Card Holder. She should be from INDIA origin.
- (ii) Applicant shall be the ward of NRI or NRI citizen by herself or Sponsored by NRI.
- (iii) The NRI / NRI Sponsor shall submit the following documents:
- a. Declaration (Annexure-II) signed by both the candidate and NRI/NRI Sponsor as per Proforma mentioned in the Prospectus/Notification of Management Quota issued by Dr.YSR UHS, Vijayawada.
- b. Evidential documents such as Green Card/Citizenship Card/ Copy of NRI's /NRI Sponsor's Bank Statement for last 6 months/ Copy of Passport issued by the respective Country/ Latest Electricity Bill/Gas Bill /Water Bill in the name of NRI/NRI Sponsor (Visa / Driving license will not be accepted) as mentioned in the Prospectus/Notification by Dr.YSR UHS, Vijayawada.

#### III. Documents to be submitted along with the application and at time of counseling:

- (a) NEET rank card
- (b) Qualifying examination marks memo
- (c) If studied abroad, equivalent certificate from recognized board in India
- (d) Proof of date of birth and place of birth.
- (e) School or college leaving certificate (transfer certificate) from the institution last studied.
- (f) Study certificate from VI class to intermediate/equivalent.
- (g) Citizenship status of the candidate (NRI Citizenship / Residence or equivalent).
- (h) Declaration (Annexure-II) by the candidate and NRI/NRI Sponsor as per Proforma mentioned in the Prospectus/Notification of Management Quota issued by Dr.YSR UHS, Vijayawada.

#### IV. SELECTION CRITERIA:

A common merit list will be prepared as to fill up the seats under NRI Category by the Dr. YSRUHS basing on the rank secured in the NEET examination (NEET qualified & eligible).

- 1. The selected candidates should done payments through online transfer/ RTGS/ SBI collect to the Director, SVIMS A/c No. 52089535266, IFSC/RTGS Code: SBIN0020926 for **Rs.25,00,000/- or equivalent US** \$ and Rs. 25,300/- (Rs.17,100 towards other fees, BLS Training -Rs.3,200/- and Caution Deposit of Rs.5,000/-).
- 2. In case, the candidate wants to cancel the admission / slide to other college within the final round of counseling, The fee will be refunded through online transfer only and it will take minimum 03 to 04 weeks time, after deducting 10% of Tuition fee (+ GST @ 18% on Tuition Fee)
- 3. If the candidate discontinues the course for any reason beyond the date of closure of admissions, she will be relieved only on payment of the tuition fee for the entire course (+ GST, if applicable).
- 4. Examination fee, Fees for issue of various certificates are extra to the candidate.

#### VII. GENERAL REGULATIONS:

- 1. All admissions shall be deemed as provisional and subject to further scrutiny. They are liable for cancellation at any time during the study by reason of incorrect or false information furnished by the applicant or her parents at the time of admission. The cancellation of admission does not exclude penal action under the relevant criminal law.
- 2. The selected candidates shall undergo medical examination by the authority specified by the university. The admission is subject to their fitness.

- 3. The admitted candidates shall abide by the rules and regulations of the university laid down from time to time.
- 4. The university reserves the right to revise any of these rules without notice.
- 5. The candidate admitted for MBBS course shall not be permitted to register for any other degree/diploma/ correspondence courses concurrently.
- 6. The candidates who got admitted in to the course shall not be given the original certificates under any circumstances. They are advised to keep sufficient Xerox copies of certificates for their future use.
- 7. The students shall maintain strict discipline during the period of study/training programme in terms of conduct rules of the institute. The candidates shall not resort to any strikes during the period of their study. The students are not permitted to approach print or electronic media, legal authorities, NMC and government directly without prior permission by the head of the institution. Their grievances (if any) shall be submitted to the Principal through proper channel. In case of violation of the conduct rules, the admission of the candidate is liable for cancellation.
- 8. The selected candidates must join the course, on the date specified by DGHS as per MCC calendar. Those who do not report before the said date, their admission shall automatically stand cancelled without further notice.

#### 9. Hostel Accommodation:

- a. All the students who require accommodation will be provided on single/shared basis on a rentfixed as per rules of the institute, subject to availability.
  - Present room rent is Rs. 2600/- for single and Rs.1300/- for shared.
- b. The Hosteller has to pay Hostel room rent for one year (12 Months) as advance at the time of joining the Hostel. Further, Hostel Deposit of Rs.5,000/- (Refundable) and Hostel Corpus fund of Rs.5,000/- (Non refundable) have to be paid at the time of joining the hostel.
- c. The Hosteller has to pay hostel mess charges, establishment charges for each academic year periodically as notified and the advance paid towards Mess charges will be adjusted against dues, if any or refunded at the time of vacating the Hostel.
- d. The inmates are adviced to go through the Hostel Rules and Regulations given in SVIMS website under Medical College Tab.
- e. No electrical/civil alternation in the room is allowed.
- f. Use of air conditioner / heaters and other electrical appliances consuming high electrical energy is not permitted in the hostel and punishable if violated.

#### 10. Academic Facilities:

The institute is approved by American Heart Association (AHA) to provide training in Basic Life Support (BLS) and Advanced Cardiac Life Support (ACLS) provider and instructor courses. It is mandatory for all the MBBS students to undergo BLS training programme on payment of Rs.3200/-.

#### 11. Medical Conditions not eligible for Admission:

Admission to the programme for the year is subject to being found medically fit by the Medical Board of SVIMS.

The candidate with the following diseases will not be eligible for admission as it would interfere with thesuccessful completion of the course.

- Any form of cancer
- Uncontrolled hypertension
- Psychiatric mental disorders
- Renal failure
- Cardiac conditions that limit normal daily activities
- Major orthopedic deformities
- Severe loss of hearing
- Severe eczema
- Color blindness
- And any other conditions which as certified by the medical board of the University would interfere with the successful completion of the course.
- Any chronic illness or treatment taken prior should be declared at the time of admission. Failure to do so may lead to dismissal from the course.

The student has to disclose her illness/s, either past or present, voluntarily in the application failing which, her admission will stand cancelled and the fees remitted will not be refunded at any cost. If found suffering with the diseases above during the course of study she will be expelled from the university.

#### 12. Ban or ragging in the campus:

Ragging, use of drugs, drug trafficking and eve teasing etc. are strictly forbidden in the university campus and persons found indulging in such activities will be subjected to strict disciplinary action as per the law. Indulging in any criminal activity within or outside the university and any physical violence against fellow students and fellow residents will not be tolerated and will attract stern disciplinary action including rustication.

As per the orders of the "Hon'ble Supreme Court of India if any incident of ragging comes to the notice of the authority of the university, the student concerned will be given liberty to explain and if her explanation is not satisfactory, the authority would expel her from the university besides making entry in her certificates to that effect. Apart from the above, the students are liable for a fine uptoRs.50,000/-, rigorous imprisonment up to three years (by court of law), and other punishments as per the Act.No.26 of 1997, dated 21-08-1997 of State of Andhra Pradesh. The abstract of the act is as per G.O.Ms.No. 67, Higher Education (EC) Department, dated 31.08.2002.

A committee is constituted by the university to deal with the menace of violence and sexual harassment against women in the campus.

The disciplinary committee is constituted by the university with Principal as Chairman to examine all the disciplinary and related issues pertaining to the students. Based on the gravity of the case, the committee shall make appropriate recommendations to the Director cum VC, SVIMS.

13 Not with-standing anything contained therein, the Principal SVIMS-SPMCW may at any time before completion of the course either on his/her own motion or on the application of any person after due and proper enquiry and after giving the person two weeks time from the date of receipt of the show cause notice to submit the written explanation and on personal hearing, recommends the cancellation of admission to the Director-cum-VC, SVIMS.

14 The students shall wear the uniform for both theory and practical classes.

15 Warning: In case any candidate is found to have supplied false information or certificate or found to have withheld or concealed certain information, she shall be debarred from continuing the course and shall face such appropriate action initiated against her by the Head of the institute and her name will be referred to Medical Council of India/NMC.

16. Library:

There is a well established library Balaji Centre for Learning in 45000 sq.ft. adjacent to SPMCW with good collection of books (22493 Nos) and subscription of foreign and Indian print journals (156). The library has back volume journal collection from the year 1993. The library is having membership of National Medical Library, New Delhi for utilization of ERMED Consortium resources. Library has internet facility with static IP address with 10 mbps speed, and scanning and photocopying facilities are available. The Library is open for 363 days in a year except on Jan 26<sup>th</sup> and Aug 15<sup>th</sup> and functions 16 hours a day i.e. 8 A.M. to 12 Midnight. During festivals, holidays and Sundays, it works from 10

A.M. to 5 P.M.

17. Games and sports:

The institute is promoting the sports and games culture among the student community by organizing coaching camps in various disciplines for the University teams. The university is member of Association of Indian universities (AIU) and students are encouraged to participate in Inter University Zonal and All India level Tournaments regular. Further, the University organizes annual competitions to inspire the student

community to involve in sports and games to improve their health status.
