The candidate has to submit the following original certificates to the verification committee.

1. Rank Card
2. Hall Ticket of the Entrance Exam.
3. B.Sc. in ECG & CVT original certificate or PG Dip. in ECG & CVT pass certificate & Marks memos.
4. B.Sc. in ECG & CVT Degree marks certificates (I, II, III years).
5. Intermediate Marks certificate
6. S.S.C. Marks certificate.
7. Transfer certificate.
8. Migration Certificate
9. Study certificate from Class IX to Degree.
10. Aadhar Card xerox.

11. No objection certificate (if employed)
12. Recently obtained caste certificate in case of BC/SC/ST categories.
13. Residence certificate(Those students who have studied outside the State of Andhra Pradesh / Telangana only have to furnish the certificate for a period of 10 years prior to the Qualifying examination that they have resided in the State).
14. The children /employees of TTD/SVIMS have to produce service certificate of the parent from the competent authority by including the name of the child and ID card of the employee.
15. **Fees: The candidate has to pay for Rs. 53,200/- towards tuition fee and the other for Rs. 2000/- towards Caution Deposit through online SB collect.**
16. There is no guarantee that all the candidates called for counseling will get the admission. All the seats will be filled up based purely on merit following the rules of reservation in vogue.
17. The decision of the counseling committee in allotting the seats shall be final and binding.
