**INSTRUCTIONS TO CANDIDATES**

The candidates are informed to attend the counselling on 26-09-2023 at 8:30 am in Sri Padmavathi Auditorium, OPD Block, SVIMS for 2<sup>nd</sup> & Spot counselling in connection with admission for the academic year 2023-24. The attendance will be taken from 8.30 am to 10.00 am only.

First 2<sup>nd</sup> counselling will be conducted and if any vacancy, spot counselling will be held.

While attending the counselling, the candidate has to submit the following original certificates to the verification committee.

1. Rank Card
2. Hall ticket of the entrance exam.
3. S.S.C. Marks certificate
4. Degree marks memos.(BPT)
5. Degree Provisional / original certificate (BPT).
6. Internship certificate.
7. Transfer certificate.
8. Migration certificate.
9. EWS certificate.
10. No objection certificate (if employed)
11. Recently obtained caste certificate in case of BC/SC/ST categories.
12. Study certificate from Class IX to Degree.
13. Residence certificate (Those students who have studied outside the State of Andhra Pradesh / Telangana only have to furnish the certificate for a period of 10 years prior to the qualifying examination that they have resided in the State).

14. The children / Regular employees of TTD/SVIMS have to produce service certificate of the parent from the competent authority by including the name of the child and ID card of the employee.
15. Fees: (a) The candidate has to pay for Rs. 1,03,200/- towards tuition fee and Rs. 2,000/- towards Caution Deposit through SB collect.
- (b). Application fee: The candidates attended for spot counselling have to pay the application fee of Rs. 5,900/- for OC/BC & Rs.4,956/- for SC/ST category through SB collect along with tuition fee.
16. There is no guarantee that all the candidates called for counselling will get the admission. All the seats will be filled up based purely on merit following the rules and reservation in vogue.
17. The decision of the admission committee in allotting the seats shall be final and binding.
18. The candidate presently working / studying and attended for the counselling must bring 'No Objection Certificate' from the employer / Principal stating that, the candidate will be relieved in time, to study the course, if selected.
19. The candidate who fails to attend the counselling on the said date will forfeit the right for admission.
20. Hostel: Shared accommodation will be provided subject to availability. Those who require accommodation have to pay the hostel deposit of Rs.10,000/- (Rs.5,000/- towards caution deposit which is refundable & Rs.5,000/- towards corpus fund) to the Hostel staff at the counselling hall.

If the candidate fails to satisfy the above, he/she shall forfeit the seat and the same will be allotted to the next person in the order of merit.

- Note :** 1. Those who have already joined in the 1<sup>st</sup> counselling are also eligible to attend for Sliding.
2. First, the seats will be filled up with candidates already reported and seeking sliding. Then, the seats will be filled with those who have already applied and did not get seat in the 1<sup>st</sup> counselling. For the remaining seats if any, spot admission will be held as per merit.
3. The guidelines prescribed in the Prospectus 2023-24 is applicable for spot counselling also.
