**MPT 2024-25 ADMISSIONS 1<sup>st</sup> COUNSELING - INTIMATION**

The candidates who have appeared in the entrance test and qualified are informed to attend before the counselling committee on **04/09/2024 at 8:30 am in Sri Padmavathi Auditorium, Second floor, OPD Block, SVIMS** in connection with admission for the academic year **2024-25**. Individual call letters were sent. The attendance will be taken from **8.30 am to 10.00 am** only.

While attending the counseling, the candidate has to submit the following original certificates to the verification committee.

1. Rank Card.
2. Hall ticket of the entrance exam.
3. S.S.C. Marks certificate.
4. Degree marks memos (BPT).
5. Degree Provisional / original certificate (BPT).
6. Internship certificate.
7. Transfer certificate.
8. EWS certificate.
9. Migration certificate.
10. No objection certificate (if employed).
11. Recent caste certificate in case of BC/SC/ST categories.
12. Study certificate from Class IX to Degree.
13. Residence certificate (Those students who have studied outside the State of Andhra Pradesh only have to furnish the certificate for a period of 10 years prior to the qualifying examination that they have resided in the State).
14. The children of regular employees of TTD/SVIMS have to produce service certificate of the parent from the competent authority by including the name of the child and ID card of the employee.
15. **Fees: The candidate has to pay of Rs. 98,200/- towards tuition fee and the other for Rs. 2,000/- towards Caution Deposit.**
16. There is no guarantee that all the candidates called for counselling will get the admission. All the seats will be filled up based purely on merit following the rules of reservation in vogue.
17. The decision of the counselling committee in allotting the seats shall be final and binding.
18. The candidate who fails to attend the counselling on the said date will forfeit the right for admission.

19. The selected candidates have to deposit all the original certificates on the day of the counselling and they will be returned only at the time of leaving the institution. Hence, they are **advised to keep sufficient no. of Xerox copies/Scanned copy (PDF) of certificates** with them for future use.
20. **Hostel** : Shared accommodation will be provided subject to availability. Those who required accommodation have to pay the hostel deposit of Rs.10,000/- (Rs.5,000/- towards caution deposit which is refundable & Rs.5,000/- towards corpus fund) to the Hostel staff at counselling hall.
