Admission guidelines for State Merit MBBS students for the AY 2025-26

## STATE MERIT QUOTA SEATS FILLED BY Dr.NTRUHS, VIJAYAWADA, A.P.

- I. The student has to submit the following documents in original at the verification counter:
  - 1) Provisional admission order of Dr.NTRUHS
  - 2) NEET Hall Ticket -2025.
  - 3) NEET 2025 RANK CARD.
  - 4) Application form.
  - 5) S.S.C. or its equivalent examination certificate as proof of the date of birth.
  - 6) Intermediate Bi.P.C Marks list.
  - 7) Transfer certificate.
  - 8) Study certificate from 6<sup>th</sup> class to intermediate (or) Residence certificate of the candidate /parents.
  - 9) Copy of the Aadhar Card.
  - 10) Valid EWS certificate (if applicable)
  - 11) Valid Special Category certificate NCC/CAP/PHC etc (if applicable).
  - 12) Valid caste certificate. (For BC, SC, ST categories only)
  - 13) Online undertaking/affidavit on anti-ragging.\*
  - 14) Filled in declaration form for eligible scholarship holders only (provided by the office).
  - 15) Copy of White ration card / Income certificate of the parent (For eligible scholarship holders)
  - 16) Joint affidavit to be executed by Parent & Student on Non-Judicial stamp paper worth of Rs.20/-
  - 17) Passport size photographs –6
  - 18) Additional one set of Xerox copies of the above documents.
- II. The classes will be commenced as per NMC Schedule and hence, the students are informed to join the college as per the schedule and they are advised to come with all the required luggage. The hostel accommodation will be provided on the day of reporting.
- III. There will be physical and clinical evaluation of the candidate by the medical board at SPMCW Hospital building and certain tests will be done to take care of holistic wellness of students.
- I. Fees Payment through <a href="https://svims.digiicampus.com/home">https://svims.digiicampus.com/home</a> only:

i) Admission fee :Rs. 9,200/-ii) Tuition & Other fees :Rs. 67,900/-

iii) College Caution deposit :Rs. 5,000/- (Refundable)

iv) BLS Training fee : Rs. 3,200/-Total : Rs.85,300/-

v) For Hostel Corpus fund : Rs. 5,000/- (Non-refundable)

vi) Hostel Caution deposit: Rs. 5,000/- (Refundable)

For hostel accommodation & dining facility, enquire in the counter with warden/matron and follow the hostel norms.

In case, the candidate wants to cancel the admission / slide to other college within the final round of counseling, the fee will be refunded through online transfer after deducting Rs. 8000/- and it will take minimum 01 month time.

- IV. Failure to submit the original certificates and fees as mentioned above within the stipulated date as notified by Dr.NTRUHS, the seat will be cancelled automatically without any notice. The candidates will not be given any extension of time to pay the fee.
- V. After submitting all the documents, payment of all fees, the admission order will be issued which has to be shown to the HODs of Anatomy, Physiology and Biochemistry on the day of reporting for attending classes.
