- **I.** The student has to submit the following documents in original in the admission cell at SVIMS-SPMCW, Tirupati:
 - 1) Provisional admission order of Dr.NTR UHS, Vijayawada.
 - 2) NEET Hall Ticket-2025
 - 3) NEET 2025 RANKCARD
 - 4) Application form
 - 5) Online undertaking/affidavit on anti-ragging.
 - 6) Copy of Aadhar Card
 - 7) S.S.C. Certificate
 - 8) Inter Bi.P.C Marks list (or) equivalent certificate from recognized board in India, if studied abroad
 - 9) Transfer certificate.
 - 10) Study certificate from 6th class to Intermediate.
 - 11) Joint affidavit to be executed by Parent & Student on Non-Judicial stamp paper worth of Rs.20/-
 - 12) Passport size photos 6
 - 13) Additional one set of Xerox copies of the above documents.

Documents required for NRI Seats:

- i) Declaration (Annexure-II) by the candidate and NRI as per Proforma mentioned in the Prospectus/Notification of Management Quota issued by Dr.NTRUHS, Vijayawada
- ii) Green Card/Citizenship Card (or)
 - Copy of NRI's Bank Statement for last 6 Months (or)
 - Pass-port issued by the respective Country (or)
 - Latest Electricity Bill/Gas Bill/ Water Bill in the name of NRI
- iii) Visa/Driving license will NOT be accepted.
