INSTRUCTIONS TO CANDIDATES

The candidates are informed to attend the 2nd & Spot counselling on 28-10-2025 at 8:30 am in Committee Hall. The attendance will be taken from 8.30 am to 10.00 am only.

While attending the counselling, the candidate has to submit the following original certificates to the verification committee.

- 1. Rank Card
- 2. Hall ticket of the entrance exam.
- 3. S.S.C. Marks certificate
- 4. B.Sc. (N) Degree marks certificate of I to IV years
- 5. B.Sc. (N) Degree provisional / original certificate.
- 6. Study certificate from Class IX to degree.
- 7. Nursing Council Registration Certificate.
- 8. Transfer certificate.
- 9. Migration certificate.
- 10. EWS certificate.
- 11. Experience certificate
- 12. No objection certificate (NOC) from the Regional Director/Commissioner APVVP as the case may be, for the candidates working in Government service to claim the seat under Government service category.
- 13. Recently obtained caste certificate from MeeSeva in case of BC/SC/ST categories.
- 14. Residence certificate (Those students who have studied outside the State of Andhra Pradesh only have to furnish the certificate for a period of 10 years prior to the qualifying examination that they have resided in the State).
- 15. The children / regular employees of TTD/SVIMS have to produce service certificate of the parent from the competent authority by including the name of the child and ID card of the employee.
- 16. (a) Fees: The tuition and other fee of Rs.88,200/- and the caution deposit of Rs.2,000/- must be paid online after verification of the original certificates at SVIMS. The payment should be made only through the link https://svims.digiicampus.com/home from the candidate's bank account, using Debit Card, Credit Card, UPI (PhonePe, Google Pay, or other UPI apps), or Net Banking. No other mode of payment will be accepted. The admission will be rejected, if the fees is not paid.

- (b). Application fee: The candidates attending the spot counselling are required to submit a duly filled application form and pay the application fee of Rs. 5,900/- for OC/BC category and Rs. 4,956/- for SC/ST category.
- 17. The candidates admitting under Spot Counselling are not eligible for scholarship.
- 18. There is no guarantee that all the candidates called for spot counselling will get the admission. All the seats will be filled up based purely on merit following the rules and reservation in vogue.
- 19. The decision of the selection committee in allotting the seats shall be final and binding.
- 20. The candidate presently working / studying and attended for the counselling must bring 'No Objection Certificate' from the employer / Principal stating that, the candidate will be relieved in time, to study the course, if selected.
- 21. **Hostel** accommodation will be provided on a first-come, first-served basis, subject to availability. Those who required accommodation have to pay the hostel deposit of Rs.10,000/- (Rs.5,000/- towards caution deposit which is refundable & Rs.5,000/- towards corpus fund) to the Hostel staff at counselling hall.

If the candidate fails to satisfy the above, he/she shall forfeit the seat and the same will be allotted to the next person in the order of merit.

- Note: 1. Those who have already joined in the $\textbf{1}^{\text{st}}$ counselling are also eligible to attend for Sliding.
 - 2. The seats will be filled up with candidates already applied appeared in Entrance Test and for seeking sliding as 1st preference. For the remaining seats if any, spot admission will be held as per the merit.
 - 3. After completion of counselling for the Local Candidates of Andhra Pradesh, the remaining vacancies will be opened for the students under the All India Category.
 - 4. The regulations prescribed in the Prospectus 2025-26 is applicable for spot counselling also.
