ORDER:

In the G.O.1st to 3rd read above, Government have issued guidelines for filling up of MBBS seats in SVIMS – Sri Padmavathi Medical College for Women, Tirupati.

2). In the reference 4th read above, the Director cum VC, SVIMS, Tirupati has informed that resolutions have been passed by the Academic Senate/Finance Committee/Executive Board of SVIMS for adopting the admission procedure of Dr NTR UHS for filling up of NRI seats in MBBS course and to fix the fee of Rs.36,00,000/- per annum on par with 'C' category of NRI quota seats in private medical colleges as notified in G.O.Ms No.146, HM&FW (C1) Dept., dt.05.11.2020 for admitting of NRI students into MBBS course in SVIMS-Sri Padmavati Medical College for Women, Tirupati from the academic year 2021-22 onwards and requested the Government to issue necessary orders in the matter.

3). The Government after careful examination of the matter and in partial modification of the orders issued in G.Os. 1st to 3rd read above, hereby issue the following guidelines for admission into MBBS course at SVIMS-Sri Padmavati Medical College for Women, Tirupati in respect of filling up of NRI Quota seats:

1. In paragraph 6, under item No.1, the words "**15% of the seats (23) shall be filled through NRI/NRI Sponsored quota through merit cum means basis with annual tuition fee of \$20,000**" shall be substituted with the words "**15% of the seats (23) shall be filled through NRI quota basing on the rank secured in NEET examination with annual tuition fee of Rs.36,00,000/- or equal to US \$ from the academic year 2021-22**".
2. The item (d), i.e. NRI Sponsored Category mentioned in Para-8 (ii) is deleted.
3. The item (e) of Para-8 (ii) is substituted with the following:
" The admission procedure of Dr. NTRUHS filling up of "C" category seats of NRI quota of MBBS course in Private un-aided and Minority Colleges shall be followed for filling up of NRI seats in SVIMS."
