In continuation to this office' Conditional LoP issued to you on 2nd July, 2014 and with reference to **Government of Andhra Pradesh's letter No. 23445/C1/2006 dated 01.08.2014** and your compliance conveyed vide letter no. **As/02/SPMC-W/SVIMS/2014 dated 28.07.2014** on the above subject. I am directed to convey that the undertaking given by the Principal Secretary on behalf of Government of Andhra Pradesh and the compliance report furnished by the Dean, **Sri Padmavati Medical Sciences College for Women at Tirupati** and undertaking furnished by Principal Secretary, Health, Medical & Family Welfare Department **Government of Andhra Pradesh** have been taken on record and the conditions attached in conditional LOP dated 02nd July, 2014 are hereby withdrawn.

2. Accordingly the **Sri Venkateshwara Institute of Medical Science, Tirupati, Andhra Pradesh** is hereby allowed to establish the new Government medical college, **Sri Padmavati Medical Sciences College for Women at Tirupati** for MBBS Course with annual admission capacity of **150 seats** for the academic year 2014-15 u/s 10 (A) of IMC Act, 1956 and as amended from time to time.

3. This permission of the Central Government for establishment of medical college and admission of students is initially for a period of one year. It will be renewed on yearly basis on verification of achievements of annual target set out in the project report. This process of annual renewal of permission will continue till such time the establishment of medical college and expansion of hospital facilities are completed as per the norms of Medical Council of India.
