This shall be a recognized medical qualification when granted by **SVIMS University, Tirupati** in respect of students being trained at SVIMS-Sri Padmavathi Medical College for Women, Tirupati with annual intake of 150 MBBS students on or after January, 2019.

- Note: 1. The recognition so granted to an undergraduate courses for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.
2. The procedure for 'Renewal' of recognition shall be same as applicable for the award for recognition.
3. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned undergraduate Course.

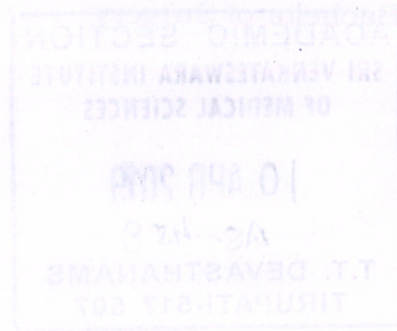

I am directed to inform you that the assessments to assess the standard of examination held by SVIMS University, Tirupati, Andhra Pradesh and to assess the physical and the other teaching facilities available for Recognition/Approval of SVIMS- Sri Padmavathi Medical College for Women, Tirupati, Andhra Pradesh for the award of MBBS degree (150 seats) granted by SVIMS University, Tirupati, Andhra Pradesh u/s 11(2) of the IMC Act, 1956 were carried out by the Council assessors on 10<sup>th</sup> & 11<sup>th</sup> January, 2019 & 31<sup>st</sup> January, 2019. The assessment reports (10<sup>th</sup> & 11<sup>th</sup> January, 2019 & 31<sup>st</sup> January, 2019) alongwith the summary/observations of the member of the Undergraduate Expert Group appointed by the Board of Governors were considered by the Board of Governors and it was decided to recommend to the Central Government for recognition/approval of SVIMS- Sri Padmavathi Medical College for Women, Tirupati, Andhra Pradesh for the award of MBBS degree (150 seats) granted by SVIMS University, Tirupati, Andhra Pradesh u/s 11(2) of the IMC Act, 1956.

The Board of Governors further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16<sup>th</sup> April 2010 and act accordingly at appropriate time, which reads as under:-

8 (3) ...

(2) The recognition so granted to an Undergraduate Course for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.

(3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.

(4) Failure to seek timely renewal of recognition as required in sub-clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute."

In view of above, you are, therefore, requested to issue necessary notification at the earliest recognizing of SVIMS- Sri Padmavathi Medical College for Women, Tirupati, Andhra Pradesh for the award of MBBS degree when granted on or after January, 2019 by SVIMS University, Tirupati, Andhra Pradesh
