While attending for the counseling, the candidate has to submit the following original certificates and fees to the verification committee. If the candidate fails to satisfy, he/she shall forfeit the seat and the same will be allotted to the next person in the order of merit.

1. **Two demand drafts for Rs. 15,000/- towards tuition fee and Rs.500/- towards Caution Deposit in favour of the Director, SVIMS drawn in any nationalized bank.**
2. Call letter
3. Intermediate marks certificate.
4. SSC certificate in support of age.
5. Permanent caste certificate in case of SC/ST/BC categories.
6. Study certificates from VI to Intermediate.
7. Residence certificate (if studied in an educational institution outside the state of AP/Telangana).
8. Recently obtained income certificate, Aadhar card & ration card for SC/ST categories for verification by the scholarship authorities for sanction of scholarship.
9. Intermediate study, conduct & transfer certificate.

Instructions to candidates:

1. The attendance will be taken from 9:00 a.m. to 10:00 a.m. only. The candidates who attend the counseling beyond 10:00 a.m. will not be considered for counseling and admission.
2. The selected candidates have to deposit all the original certificates on the day of the counseling and they will be returned only at the time of leaving the institution. Hence, they are **advised to keep sufficient no. of Xerox copies of certificates** with them for future use.
3. There is no guarantee that all the candidates called for counseling will get the admission. All the seats will be filled-up based purely on merit following the rules and reservation in vogue.
4. The decision of the selection committee in allotting the seat shall be final and binding.
5. The candidate who fails to attend the counseling on the said date, will forfeit the right for admission.
6. The candidate should not be continuing another course / job while attending the counseling. If so, they must bring 'No Objection Certificate' that, the candidate will be relieved in time, to study the course, if selected.
