The candidates are informed to appear before the selection committee on **22-07-2015 at 09:00 AM in the Committee Hall, SVIMS** for counseling in connection with admission for the academic year 2015-16.

While attending for the counseling, the candidate has to submit the following original certificates and fees to the verification committee. If the candidate fails to satisfy, he/she shall forfeit the seat and the same will be allotted to the next person in the order of merit.

- 1. Call letter
- 2. SSC certificate.
- 3. MBBS degree certificate.
- 4. MS/DNB Certificate.
- 5. Registration certificate of MBBS & MS/MD/DNB.
- 6. No. of attempts certificate for MBBS & MS/MD/DNB.
- 7. NOC from their employer for those who are working in Govt. / public sector undertakings.
- 8. Residence certificate (if studied in an educational institution outside the state of AP/Telengana).
- 9. Demand draft for Rs. 57,850/- drawn in any Nationalized bank in favour of the Director, SVIMS, Tirupati payable at Tirupati towards fee and caution deposit of Rs.500/- is to be paid by way of challan, if selected.
- 10. Bond for Rs. 50,000/- is to be submitted in Rs. 100/- non-judicial stamp paper as per the proforma within 1 week, if selected.

Instructions to candidates:

- 1. No TA/DA will be paid for attending the counseling.
- 2. This call letter does not guarantee admission for the course.
- 3. If the candidate is unable to produce the original certificates as mentioned above during the counseling, he/she will not be permitted for counseling.
- 4. The attendance will be taken from 09:00 a.m to 10:00 a.m only. The candidates who attend the counseling beyond 10:00 a.m will not be considered for counseling and admission.
- 5. The selected candidates have to deposit all the original certificates on the day of the counseling and they will be returned only at the time of leaving the institution. Hence, they are **advised to keep sufficient no. of xerox copies of certificates** with them for future use.
- 6. There is no guarantee that all the candidates called for counseling will get the admission. All the seats will be filled-up based purely on merit following the rules and reservation in vogue.
- 7. **Method of Selection**: Based on Viva-voce by the HoD and interview by the committee.
- 8. The decision of the selection committee in allotting the seats shall be final and binding.
- 9. The candidates who fail to submit aforesaid original certificates and fees on the day of counseling, will forfeit the right for admission.
- 10. The candidate who fail to attend the counseling on the said date, will forfeit the right for admission.
- 11. The candidate should not be continuing another course / job while attending the counseling. If so, they must bring 'No Objection Certificate' to attend for the counseling.
