ORDER:

In the letter read above, the Director-cum-VC, Sri Venkateshwara Institute of Medical Sciences, Tirupati has reported that in the Governing Council Meeting of Sri Venkateswara Institute of Medical Sciences held in the chambers of Hon'ble Chief Minister, Andhra Pradesh, dated.14.08.2014, the following decisions were take with regard to SVIMS Sri Padmavathi Medical College for Women, Tirupati.

- 1. 85% of the seats (127) shall be filled through merit with annual tution fee of Rs.60,000/- 15% of the seats (23) shall be filled through NRI/NRI sponsored quota through merit cum means basis with annual tution fee of \$ 20,000.
- 2. Out of 85% of merit seats, 85% shall be filled with the eligible local candidates of the residual state of Andhra Pradesh (13 Districts) and 15% shall be filled under unreserved category.
- 2. It is also reported that Govt. of India vide letter dated:08-08-2014 have granted permission for establishment of the Medical College with annual admission capacity of 150 seats for women for the academic year 2014-15 by SVIMS, Tirupati.
- 3. The Director-cum-VC, SVIMS, Tirupati has further reported that in view of the commencement of the academic session from 1st September, 2014 as per the Medical Council of India and the judgment of the Hon'ble Supreme court of India and due to shortage of time, carrying the admission process by SVIMS itself (i.e. calling applications conduct of entrance test, counseling etc.) is very difficult. The A.P.State Council of Higher Education conducted EAMCET examination for all the eligible candidates of Andhra Pradesh (for medical stream) and ranks were declared. Dr.NTRUHS is well versed in conducting the counseling for MBBS admissions.
- 4. She has further stated that for this academic session (2014-15), Dr.NTRUHS may be advised to fill 85% of seats i.e. 127 seats in the ratio of 85:15 (local : UR) by collecting the tution fee and later transfer to SVIMS. The remaining 15% of seats i.e. 23 seats may be permitted to be filled with NRI quota duly notifying by SVIMS itself as per the procedure and instructions by the Government.
- 5. The Director-cum-VC, SVIMS, Tirupati has requested the Government for issue of necessary orders to Dr.NTRUHS for filling merit seats of Sri Padmavathi Medical College for Women and Sri Venkateshwara Institute of Medical Sciences, Tirupati for filling the NRI/NRI sponsored quota seats for the academic session 2014-15.

- 6. The Government after careful examination of the matter hereby prescribe the following apportionment of seats among Local, Un Reserved and NRI / NRI sponsored categories for filling up of seats in Sri Padmavathi Medical College for Women being run under Sri Venkateshwara Institute of Medical Sciences, Tirupati for the academic session 2014-15
 - 1. 85% of the seats (127) shall be filled through merit basing on EAMCET ranking amongst those who secured qualifying marks in the EAMCET-2014, with an annual tution fee of Rs.60,000/- 15% of the seats (23) shall be filled through NRI/NRI sponsored quota through merit cum means basis with annual tution fee of \$ 20,000.
 - 2. Out of 85% of merit seats, 85% ie., 108 seats should be reserved for the eligible local candidates of the State of Andhra Pradesh, and the remaining 15% i.e., 19 seats shall be unreserved seats as specified in the Andhra Pradesh Educational Institutions (Regulation of Admissions) Order, 1974, as subsequently amended, subject to following Rule of Reservation.
- 7. The Registrar, Dr.NTR University of Health Sciences, Vijayawada shall fill the 85% seats through the counselling and allot the candidates to SVIMS-Sri Padmavathi Medical College for Women, Tirupathi.
- 8. The general guidelines for the admission of candidates into MBBS course shall be as follows:
 - (i) For 85% of the seats, the counseling shall be conducted by Dr.NTRUHS, Vijayawada as per the regulations of the University. The Candidate should satisfy Local / Non-Local status requirement for admission into 85% of seats as laid down in the Andhra Pradesh Educational Institutions (Regulation of Admissions) Order, 1974 as subsequently amended.
 - (ii) All the NRI/NRI sponsored seats, shall be filled by SVIMS through merit cum means basis following the procedure as laid down hereunder.
 - a. SVIMS shall notify for admission to MBBS course with the details of intake, schedule of admissions, cost of application form in popular news dailies which is to be displayed on the institute's website and also on the notice board.
 - b. The blank application form and prospectus for admission shall be made available to the candidates from the institution counter on payment of the prescribed fee. The facility for downloading the form of application from the SVIMS website should also be provided. The applicant has to pay the prescribed fee along with duly filled in application at time of submission.
 - c. SVIMS authorities shall enter the day wise sale of applications with the name of the candidates and address in a Register opened for the purpose and it shall be made available for inspection.
 - d. The institute shall issue an acknowledgement / receipt for the applications received.
 - e. The institution shall obtain ratification from the Executive board / Governing Council of SVIMS for all the admissions (85% merit seats by Dr.NTRUHS and 15% NRI/NRI sponsored seats by SVIMS).
 - f. The institution shall collect the tuition fees of US \$ 20,000 p.a for five years from students admitted under NRI category seats.

9. The Registrar, Dr.NTR University of Health Sciences, Vijayawada / The Director-cum-VC, SVIMS, Tirupati shall take necessary action in the matter.
