Instructions for Counseling for PG Medical (MD) Courses-2015

First counseling for PG Medical (MD) Courses will be held on 08.04.2015 in the Auditorium, OPD block of SVIMS for the following programmes:

- 1. The merit list of the candidates who appeared for SVIMS entrance test is displayed in the institute website.
- The candidate who have secured a minimum of 50% marks for Open Category, 40% marks for SC, ST and BC category and 45% marks for PWD category are eligible to attend the counseling.
- 3. The candidates have to report at 8.30 am in the Registration desk for biometric registration of the photograph & finger print and the same will be authenticated against pre-existing data.

COUNSELING PROCEDURE:

- 4. The qualified candidates shall report for counseling in person with the following original certificates as detailed in **Appendix III** of the prospectus for verification.
 - i. e-Hall ticket and Rank card.
 - ii. 10th class (SSC) certificate
 - iii. MBBS degree certificate
 - iv. MBBS consolidated marks memo
 - v. Certificate of Internship
 - vi. Medical council registration certificate
 - vii. Transfer / Migration certificate of MBBS.
 - viii. Study & Conduct certificates Inter to MBBS (7 years) and additionally for those who have studied MBBS in state-wide universities / State-wide institutions (Siddartha Medical College, Vijayawada) as defined in the G.O.P.No. 646 dt: 10th July, 1979 shall also bring study certificate from class VI to X.
 - ix. Integrated permanent community certificate for SC/ST/BC categories

- x. Residence certificate issued by Tahsildar in the proforma as per Annexure-II of PG Medical courses in the institute's website (for candidates who have not studied in any institution during the whole or any part of ten consecutive academic years in Andhra Pradesh immediately preceding the qualifying examination) (or) any other document to prove their non-local status as per appendix-II (3) of prospectus.
- xi. Person with disability (PWD) certificate/s those who are fulfilling the conditions mentioned under V (2) of the prospectus.
- xii. DD for Rs. 32,000/- drawn in favour of the Director, SVIMS, Tirupati towards admission and other fee (non refundable).
- 5. The candidates who are claiming admission under PWD category shall appear one day before the day of counseling i.e. on 07.04.2015 at 9.00 am in the committee hall, SVIMS for physical examination by the Medical Board constituted by the institute. Their admission is subject to fulfillment of the following:
 - i. The differently abled candidates with locomotory disability of lower limbs between 50% 70% are eligible for admission.
 - ii. In case, unavailability of candidates with locomotory disability of lower limbs between 50% 70%, then such unfilled seat shall be filled up by persons with locomotory disability of lower limbs between 40% to 50%.
 - iii. Candidates with less than 40% disability are not eligible for the benefit of reservation under PH category.
 - iv. The disability certificate should be produced by a duly constituted and authorized Medical Board of the Govt. Medical College/State or Central Govt. Hospitals/ Institutions.
 - v. The disability certificate should be issued, within 3 months prior to last date for submission of application. The Medical Board constituted by SVIMS will scrutinize / verify the disability certificate and on physical assessment will confirm the extent of disability and eligibility for admission.
 - vi. The decision of the SVIMS Medical Board on his/her physical disability status shall be final.
 - vii. The candidate who have secured a minimum 45% marks in the entrance test are eligible to attend the counseling
- 6. Not attending to the counseling or failure to bring and deposit the required certificates and fee shall render the candidate forfeiting his/her right for admission and the next candidate in the order of merit will be preferred.
- 7. The candidate has to attend in person for counseling. No proxy/representative is permitted under any circumstances.
- 8. No request for postponing the date of counseling or request to appear at a later or earlier date shall be entertained.

- Those who have not completed internship on or before 31.03.2015 and do not submit internship certificate on the date of counseling are not eligible for admission irrespective of the rank obtained in the entrance test.
- 10. The candidates are instructed to comply with all the instructions stipulated in the prospectus prior to and after admission.
- 11. The candidates will be called for counseling in the order of roster point from the 100 points roster system beginning with roster point No.56 for this academic year in the order of merit as mentioned below.

- 12. The counseling will be done according to the merit in each category (UR/OC/BC/SC/ST/OPH) as per the roster point allocation method and not by the overall rank.
- 13. The selected candidate shall deposit all the original certificates and pay the annual fee on the date of counseling as specified below:

- 14. In service candidates and those who are pursuing studies at other institutions and who cannot deposit the original certificates at the time of counseling have to bring the following:
 - A certificate in original signed by the Principal / Dean mentioning the course, date of admission and the list of original certificates in their college/ institution.
 - The fee receipt for admission issued by the college in original.
 - iii. Attested photo copies of the original certificates retained in that college.
 - iv. "No objection Certificate" from the parent Institution that such Institution has No Objection to the candidate's admission to undergo the post-graduate course at SVIMS and in the event of selection of the candidate to the course, he/she shall be relieved immediately.
 - v. In case of selection of such candidate, subsequently have to submit the original certificates within one week from the date of counseling, failing which, they will forfeit the right for admission.
- 15. In all matters relating to selection and admission, the decision of the Institute shall be final and binding on the candidate and selection cannot be questioned after admissions are closed.
- 17. The selected candidate has to produce the following on the date of joining:
 - Medical fitness certificate certified by the Medical Officer, not lower than the rank of Civil Surgeon/ Professor working in a Government Institution
 - ii. The bond/s as per the proforma furnished in the prospectus (Appendix IV),
 - iii. A copy of the PAN card
 - iv. One set of photocopy of all the certificates, Two photos
- 18. The second & final counseling schedule will be notified in the website. No individual communication will be sent. The candidates have to visit the website and attend for the counseling along with their certificates and fees.
- 19. Ragging is strictly prohibited. If any incident of ragging comes to the notice of the authorities, necessary action will be taken as per the institute/ Govt. / MCI norms.
