The candidates have to attend in person with the following **certificates in original** for admission into MPT course

1. Call letter.

3. Degree marks certificate (BPT).
4. Degree Provisional / original certificate.
5. Internship certificate.
6. Transfer certificate.
7. Migration certificate.
8. No objection certificate (if employed)
9. Recently obtained caste certificate from Mee Seva in case of BC/SC/ST categories.
10. Study certificate from Class IX to degree.
11. Residence certificate (for those who have studied outside the state of A.P/Telangana)

12. TTD/SVIMS category certificate
(ID card, Service certificate with dependents list from the competent authority)
13. **Fees: The candidate has to bring two demand drafts for Rs. 1,03,200/- towards tuition fee and Rs. 2,000/- towards other fees in favour of the Director, SVIMS, Tirupati drawn in any nationalized bank. Failing which, the seat will be offered to next merit candidate.**

If the candidate fails to satisfy the above, he/she shall forfeit the seat and the same will be allotted to the next person in the order of merit.

Note:

1. **The attendance will be taken from 8:30 am to 10:00 am only.** The candidates who attend the counseling beyond 10:00 am will not be considered for counseling and admission.
2. The selected candidates have to deposit all the original certificates on the day of the counseling and they will be returned only at the time of leaving the institution. Hence, they are **advised to keep sufficient no. of Xerox copies of certificates** with them for future use.
3. There is no guarantee that all the candidates called for counseling will get the admission. All the seats will be filled up based purely on merit following the rule and reservation in vogue.
4. The decision of the selection committee in allotting the seats shall be final and binding.
5. The candidate who fails to attend the counseling on the said date will forfeit the right for admission.
6. The candidates should not be continuing in another course / job while attending the counseling. If so, they must bring 'No Objection Certificate' that, the candidate will be relieved in time, to study the course, if selected.
