INSTRUCTIONS TO CANDIDATE

1. The candidate has to appear for the examination at the centre, date and time as specified in the Hall ticket.

4. No candidate shall be allowed to leave the examination hall till the last bell is given.
5. Candidate has to leave the examination hall only after handing over the answersheet to the invigilator concerned.
6. The Candidate is required to bring his/her own blue/black ball point pen for writing the test. He/She is requested to note that nothing will be allowed inside the examination hall, except pen, pencil exam writing material and hall ticket.
