- Authors are encouraged to participate in peer review process and have to provide suggestions regard at least 3 “suggested reviewers” and 3 “not-suggested reviewers” (w.e.f of 1st issue of 2017).
- All authors’ contribution must be specifically stated in copyright/Undertaking forms.
- All authors are obliged to provide retractions or corrections of mistakes.

6. Peer-review process

- All of a journal’s content is subjected to a double – blind peer-review.

The journal follows the "Uniform Requirements for Manuscripts Submitted to Biomedical Journals" advocated by the International Committee of Medical Journal Editors (ICMJE) (available at URL: http://www.icmje.org/urm_full.pdf). The manuscript, when received along with the “Undertaking by the Authors” “Copyright Transfer” and “Conflict of Interest” forms, is assigned a unique identification number. Then the manuscript is sent for double blinded peer review to two reviewers. Acting upon the evaluation reports submitted by the reviewers, the Executive Editor-in-Chief decides whether the manuscript is suitable in the present form for publication /needs revision and resubmission/ is not suitable for publication. The usual time lag from receipt of manuscript complete in all aspects and decision making is 8-12 weeks.

- Review format is objective. Reviewers have to declare that they have no conflicts of interest. Reviewers should point out relevant published work which is not yet cited.
- Reviewed articles are treated confidentially and peer review process is double - blinded

7. Publication ethics

- The Journal takes all possible steps to identify and prevent the publication of papers where research misconduct has occurred and its editors do not encourage such misconduct, or knowingly allow such misconduct to take place.
- iThenticate® is used to check plagiarism.
- In the event that a journal’s publisher or editors are made aware of any allegation of research misconduct the publisher or editor shall deal with allegations appropriately.
