#### **SALIENT POINTS TO BE NOTED:**

- 1) Online (e-tendering) tenders are invited for providing of medical oxygen gas supply points (medical oxygen, air, vacuum and nitrous oxide) at medical oncology department and medicine ward at 2nd floor of specialty block and proposed new gastroenterology department and medicine ward at 3rd floor of sri padmavathi opd block (above auditorium), svims. This tender is in two bid system i.e., (1) Technical bid and (2) Financial bid.
- 2) If two or more tenderers attained the same rank in the price comparison, the experience of the tenderers in this field and the track record of the tenderer etc., will be taken into consideration for issuing "Award of Contract".
- 3) The tenderer should not submit any kind of financial details in the hard copies to be submitted to SVIMS., i.e., in the Technical Bid Cover / Hard Copy Cover. If found in any cover, bid will be invalidated. The price quoted in the financial bid of e-procurement platform will only be taken into consideration.
- 4) The tenderers are advised to go through each and every line of tender document carefully before final submission.
- 5) In case of Partnership Firm, the following documents should be uploaded along with GST / PAN:
  - a) A copy of Deed of Partnership
  - b) A copy of list of partners with names and addresses
  - c) Only Managing Partner has to sign the documents and represent the company in person for any discussions.
- 6) In case of a Company, the following documents should be uploaded along with GST / PAN:
  - a) A copy of Memorandum of Understanding
  - b) Articles of Association
- 7) In case of Proprietorship, the owner of the company has to sign in all the documents and represent the company in person for any discussions.
- 8) The financial bids of those tenderers who are technically qualified will only be opened. The SVIMS may extend the last date by issuing a corrigendum in which case all rights and obligations of the SVIMS and the tenderers previously subject to the original deadline will then be subjected to the new deadline.
- 9) Date of opening of price bid given in the e-tender platform is tentative and liable for change.
- 10) Quoting maximum discount just for acquiring the tender will not be the only criteria for award of Contract. Therefore, tenderer should carefully assess the work before offering the rates.

#### 13) PROCEDURE FOR QUOTING THE PRICE:

- a) The tenderers who have quoted for all specifications mentioned in Annexure-I and II alone will be considered otherwise such tenders will be rejected.
- b) Tenders will be finalized basing on the total lowest amount offered for all items mentioned in Annexure I and II.
- c) The rates quoted should be exclusive of all taxes.
- d) The rates quoted by L1 Tenderer is liable for negotiations after price bid.

- 14. Offline submission of tender document will not transferable in any manner.
- 15. The tender inviting authority reserves the right to reject any or all tenders or postpone the tenders without assigning any reason.

#### EARNEST MONEY DEPOSIT (Rs. 1,00,000):-

- 1) Earnest Money Deposit as mentioned under Mandatory Documents shall be paid by way of Demand Draft drawn in favour of "The Director, SVIMS, Tirupati", payable at Tirupati on any scheduled bank and the original DD., should be submitted before opening the technical bid.
- 2) EMD will not be accepted in the form of Cheques, postal orders, bank guarantees or bank demand drafts issued on the personal name of the officers of SVIMS, Tirupati or by any other mode of remittance.
- 3) The E.M.D. will be returned to the unsuccessful Tenderer on the date of finalization of the Tender without interest.

#### SECURITY DEPOSIT (Rs. 3,00,000/-) & AGREEMENT :-

- 1) Successful Tenderer shall be required to pay/submit the following within 14 (fourteen) days from the date of "Award of Contract":
  - a)Security Deposit of Rs. 3,00,000/- (Rupees Five lakhs only)
  - b)An agreement on sufficient value of Non-judicial stamp paper for faithful and satisfactory performance of contract. (The institute will supply the specimen of the agreement to the successful tenderer)

The date of commencement of the Contract work will be mentioned in the Award of Contract and the same will be treated for period of contract / tenure. A letter by mentioning the date of the commencement of the contract work must be submitted to the TIA.

- 2) The Security Deposit shall be paid by way of Demand Draft drawn in favour of "The Director, SVIMS., Tirupati" and the said deposit will be returned only after 06 months from the date of completion and handing over of pipeline works to SVIMS without interest, subject to penalties / deductions.
- 3) If the successful tenderer fails to pay the security deposit and to execute an agreement within the period of 14 days from the date of "Award of Contract", such failure will constitute a breach of terms and conditions of the contract. Consequently, the contract shall be cancelled and the TIA will forfeit the EMD., in addition to recovery of any loss sustained by the Institute.
- 4) The TIA will forfeit the Security Deposit for any non-performance of the tender as defined in the tender conditions during the tender period and action will be initiated for black listing the tenderer.

#### Note:

#### **BASIC INFORMATION TO THE TENDERER:**

- 1. The Tenderer uploading his tender would be deemed to have considered and accepted all the terms and conditions of tender. No verbal or written enquiries shall be entertained in respect of acceptance or rejection of the tender.
- 2. If the tenderer gives deliberately wrong information to create conditions for acceptance of the tender, the Director-cum-VC., SVIMS., reserves the right to reject such tenders without assigning any reason. Not more than one tender will be submitted by one tenderer for the same work. Legal action will be taken for furnishing wrong information.
- 3. The successful tenderer shall be required to execute an agreement on sufficient value of non-judicial stamp paper.
- 4. The successful tenderer shall have to follow all the instructions given to him/them from time to time by the competent authority or person nominated by him.
- 5. The successful tenderer shall maintain a register for the routine instructions.
- 6. The successful tenderer shall be liable to pay compensation for any loss or damage caused to the property of the Institute under the contract.
- 7. The successful tenderer is responsible for any illegal activity of the employee done by him during his work / presence in the Institute / Hospital premises.
- 8. The successful tenderer shall comply with all instructions/direction/rules and regulations of any statutory authority and discharge all obligations, imposed upon him by the statutory authorities or under any law and shall indemnify the Institute and officers/employees from any claim or consequences/damages for any lapse or non compliance thereof.
- 9. The successful tenderer will be responsible for any accident or mishap or death of workers engaged by him and for payment of any claim made on this account and shall also indemnify the Institute from any claim in this regards.
- 10. The successful tenderer and his worker shall abide by the rules and regulations of the Institute as well as directions/instructions issued by the Director-cum-VC., of Institute or on his behalf by the authorities from time to time and violation of which may result in cancellation of the contract.
- 11. In the event of infringement of any law by any of the workers engaged by the successful tenderer, he shall be under obligation to change the worker immediately on the instruction of the Institute authorities.
- 12. The tenderer is suggested to carefully go through the terms and conditions of the document before offering his/their rates.
- 13. The tenderers / successful tenderer who are black listed elsewhere, but not revealed in the tender process or given any other wrong declaration and if it is found at a later date, the following penalties will be applicable":
  - a) If it is found during technical evaluation / before opening price bid: "the bid will be disqualified and the EMD amount will be forfeited".
  - b) If it is found after Award of Work contract, EMD and S.D will be forfeited

- 14. TDS will be deducted as per Income Tax Act 1961, if applicable.
- 15. GST extra as per statutory rules of the Government from time to time.
- 16. All the tenderers shall invariably upload the <u>clearly visible</u> scanned copies of Mandatory requirements in e-Procurement system and this will be the primary requirement to consider the bid responsive.
- 17. The related documents should be uploaded in the respective fields only. If uploaded in any other fields or areas and not traceable by SVIMS, it will be construed that the tenderer has not uploaded the related document and SVIMS is not responsible for such lapse by the tenderer and the same will be treated as non-submission of the said document.
- 1. GST is applicable and it should be shown separately provided in the column on the e-procurement platform. If GST is not mentioned separately, it will be added to the final quoted price.

#### TERMS & CONDITIONS OF THE CONTRACT:-

- 1. All the firms/persons shall have been in the market for atleast <u>two</u> years in the same nature of works, prior to the date of submission of online tender. This condition does not however apply to public sector undertakings and government undertakings. The S.V.Institute of Medical Sciences, Tirupati at its discretion may relax the condition of 3 years standing in market in respect of tenderers who offer propietory, special sophisticated unique items.
- 2. If the tender is submitted by an individual it shall be signed by him giving his full name and address. If it is submitted by a firm, it shall be signed by a member of the firm. The tender received shall be valid for a period of two months from the date of opening of tenders. During the above mentioned period, no plea by the tenderer for any sort of modifications of the tender, based upon arising out of any alleged misunderstanding or misconception or mistake or for any other reason will be entertained.
- 3. The tenderers are expected to visit the site of work and acquaint themselves with the conditions prevailing before their rates.
- 4. Time shall be considered as the essence of the contract. Date of commencement of this work shall be the date on which the letter of intent/work order is issued to the successful tenderer.
- 5. The quoted prices and unit rates shall include the following:
  - a) Transport from the place of manufacture to the places of installation, loading and unloading and storage and safe custody.
  - b) All risks of loss of or damage to physical property and of personnel injury and death, which arise during and in consequence of the performance of the contract, are the responsibility of the contractor.
  - c) Erection, Testing and commissioning.
  - d) The prices shall be firm till the entire installation is handed over and shall be free from any fluctuation in the cost of raw materials and labour etc.

- e) The quoted rate shall be self sustaining and shall remain valid for any increase or decerease in quantity.
- f) SVIMS, will not however after acceptance of contract rate pay any extra charges for lead or for any reason, incase the contractor is found later on to have misjudged the materials available. Attention of the contractor is directed to the standard prelimnary specification regarding payment of seigniorage, tools etc.
- g) No part of the contract shall be sublet without written permission of the Director, SVIMS, Tirupati nor transfer be made by power of attorney authorizing others to receive payments on the contractors behalf.
- h) No tenderer will be permitted to withdraw his tender before the final disposal of the tenders by the competent authorities concerned.
- i) In exceptional circumstances, prior to expiry of the orginal time limit, the tender inviting officer may request the tenderers to extend the period of validity for a specified additional period. Such request to the tenderers shall be made in writing. A tenderer may refuse the request without forfeiting his E.M.D. A tenderer agreeing to the request will not be perimitted to modify his tender, but will be required to extend the validity of his EMD for a period of the extension.
- 6. As per the instructions of the APTS., Vijayawada, e-procurement fund (Corpus fund 0.04%) shall be paid by the L1 bidder through online and submit the payment details to the TIA.

#### **SUPPLY:**

- a) Supplies should strictly confirm to the specification mentioned in the order.
- b) Tenders which are not in accordance with the specifications mentioned, are liable for rejection.
- c) The decision of the Director, Sri Venkateswara Institute of Medical Sciences, Tirupati shall be final as regards the acceptability of the items supplied by the approved tenderer and the institute shall not give any reason in writing or otherwise at any time for rejection of items.

#### **PAYMENT:**

50% cost of material supplied at site.

Balance will be paid after completion of Installation.

## THE WORK SHOULD STRICTLY CONFIRM TO THE FOLLOWING TECHNICAL SPECIFICATIONS:

#### **COPPER PIPE:**

Solid drawn, seamless, deoxidised, non arsenical, half hard, tempered degreased materials confirming to EN – 13348 medical grade. Before despatch, all the pipes should be delivered plugged or capped at both ends.

#### **COPPER FITTINGS:**

All fittings shall be made of copper especially made for brazed socket type connections.

#### **PAINTING OF PIPES:**

All exposed pipes should be painted two coats of synthetic enamel paint and colour codification as per IS - 2379 of 1963.

#### **OUTLET POINTS**: (OHMEDA DIAMOND COMPATIBLE-TYPE)

All outlets shall be quick connect and gas specific for the service indicated (viz. O2, N2O, Air, Vac) and accepted only with compatible quick connect adaptors. The outlet point should meet NFPA-99 standard. All outlets should be tested and cleaned for oxygen service prior to shipping. A complete outlet should consists of a gas specific rough in assembly and a matching gas specific finishing assembling consists of latch valve assembly.

Outlets shall be manufactured with an 6-1/2" (165 mm) length type "K" ½" (12.7) outside diameter (3/8" nominal) size copper inlet pipe stub which is silver brazed to the outlet body. For positive pressure gas service, the outlet shall be equipped with a primary and secondary check valve and the secondary check valve shall be rated at a minimum 200 psi [1,379 kPa] in the event the primary check valve is removed for maintenance. Outlet bodies shall be gas specific by indexing each gas service to a gas specific dual pin indexing arrangement on the respective identification module.

A large color coded front plate shall be used for ease of gas identification and aesthetic appeal. The latch valve assembly shall be Ohmeda Diamond compatible type and accept only corresponding Ohmeda diamond type gas specific adapters.

#### **ISOLATION VALVES:**

Valves should be suitable for the pipe dia. and should be of non lubricated 90 degree turn lever ball valves of IBP Conex make with PTFE seat, having opening by quarter turn of handle. Sizes should be appropriate for copper pipes with screw threaded ends with matching nuts. All valves should be pneumatically tested for twice the working pressure and degreased for medical gas service.

#### **OXYGEN FLOWMETER (INDIGENOUS):**

Flowmeter shall be Back Pressure Compensated. It should be accurate gas flow measurement and control within a range of 0 - 15 litres per minute. It should meet strict precision and durability standards. Flowmeter body will be made of brass material. Flow tube and shroud components should be made of clear, impact resistant poly carbonate. The humidifier bottle shall be made of unbreakable poly carbonate material and autoclavable at 134 degrees Centigrade.

#### **WARD VACUUM UNIT (INDIGENOUS):**

It should comprise of one number Vacuum regulator with guage, both mounted on a collection jar of capacity 600 ml and with a wall bracket for mounting it on the wall. The collection jar shall be made of unbreakable polycarbonate material which is fully autoclavable at 134 degrees centigrade.

#### THEATRE VACUUM UNIT (INDIGENOUS):

- The unit should comprise of two reusable 2000 ml shatter resistant bottle, each made up of poly carbonate material and fully autoclavable at 134 degree centigrade.
- It should have a vacuum regulator with instant ON / OFF switch and a three way selector switch with an option to operate either Left, Right or Both.
- All the above items should be mounted on a Trolley having free moving castor wheels.

#### **NITROUS OXIDE MANIFOLD:**

2 x 2 Cylinder Nitrous Oxide Manifold should be suitable to withstand a pressure of 145 Kg/cm2, along with high-pressure copper annealed tail pipes with end Brass adapter suitable for N2O Cylinders and manifold.

Top frame comprising of high pressure copper pipes of size 1/2" I.D. x 15swg with high pressure brass fittings made of high tensile brass and connections through non- return valves; high pressure copper tail pipes, made of high pressure copper pipe of size 1/4" I.D. x 15 swg. The design of middle and bottom frames should be provided to fit both round and flat bottom cylinders safely.

#### Nitrous Oxide Control Panel with Alarm

- Control panel should have two first stage regulators each capable of delivering 100
   200 psig outlet pressure.
- The first stage regulator should be connected to the second stage regulator, which will deliver an outlet pressure of 60 psig.
- The first two regulators meant for first stage will be capable of switchover system incorporated from "RUNNING" to "RESERVE" bank due to differential pressure.
- The control panel should provide for two individual contact pressure guages to indicate the cylinder pressure in the two wings of the manifold and common pressure guages to indicate the delivery/line pressure.
- The control panel should be covered with suitable cover indicating the respective services.
- Control panel should have built in transformer to ensure safe operation by low voltage.

#### **VACUUM SYSTEM:**

The Vacuum system shall consist of two nos. vacuum pumps with motors, electrical switch gear and automatic control system, one number vacuum reservoir and inter-connecting piping, filters, valves and fittings thereof.

#### **DISPUTE:-**

- i) If any dispute or difference arises between the parties relating or concerning or to interpretation of the contract or any alleged breach thereof or any matter relating to the contract, the same shall be settled by the parties as far possible by mutual discussion and consultation between themselves, which are arisen during the subsistence of the contract or thereafter.
- ii) In the event of any dispute or differences arises in connection with the contract arising out of this Tender whether during the subsistence of the contract or there after not being settled in aforesaid manner, the matter shall be referred to the Director-cum-VC., SVIMS., Tirupati or his nominee not below the rank of Deputy Director/Professor for arbitration whose decision shall be final and binding on both the parties. The proceedings before the arbitrator would be governed by the provision of the ARBITRATION AND CONCILIATION ACT, 1996.
- iii) The courts at TIRUPATI shall have exclusive jurisdiction in all matters arises out of this Tender.

#### **SUB-CONTRACTING:-**

To whom the contract is awarded shall only execute the contract and letting of subcontract is not allowed and will attract punishment including termination of contract, forfeiture the Security Deposit and payment of loss incurred to SVIMS due to termination of contract.

#### **INDEMNITY:-**

The tenderer shall indemnify the SVIMS., against all actions, suits, claims and demands brought or made against it in respect of anything done or committed to be done by the tenderer in execution or in connection with the work of this contract and against any loss or damage to the hospital in consequence of any action or suit being brought against the tenderer for anything done or committed to be done in the execution of this contract.

#### **DISCLOSURE OF INFORMATION:-**

The tenderer has to abide that all knowledge and information not within the public domain which may be acquired during the carrying out of this contract, shall be for all time and for all purpose, regarded as strictly confidential and held in confidence, and shall not be directly or indirectly disclosed to any person whatsoever, except with the written permission of SVIMS.

#### **FORCE MAJEURE CLAUSE:-**

Any act of God, shall not disentitle the parties to this Agreement to terminate the Contract or claim damages. Whether an "act" will come within the purview of the "Act of God" or not will be decided by the SVIMS and its decision will be final.

#### **TERMINATION OF CONTRACT:-**

The terminations for failing to fulfill any of the terms and conditions of this contract are as below:

In case the successful tenderer back out after releasing the "Award of Contract" or fails to comply with the terms and conditions within the period, the tenderer will be liable to make good the loss sustained by the Institute in addition to the penalty as under:-

- 1) The Tender Inviting Authority shall be entitled to approve any other tenderer without notice to the successful tenderer and to recover the extra cost thus involved from the successful tenderer.
- 2) To cancel the contract.
- 3) To forfeit the EMD and / or Security Deposit to the extent of the loss incurred by the Institute, in the event of action being taken as above and if it falls short, the Tender Inviting Authority shall be at liberty to take action against the tenderer or by instituting a Civil Suit. In this regard, the tenderer shall not be entitled to any gain.
- **4)** Any under payment or indulgence in the financial lapse shall result in termination of contract without any notice whatsoever.

#### **INDULGENCE IN CORRUPT OR FRAUDULENT PRACTICES:-**

The Institute requires that the tenderer under this tender shall observe the highest standards of ethics during the procurement and execution of this contract. In pursuance of this policy, the terms set out are as follows:

- a) "Corrupt practice" means offering, giving, receiving or soliciting anything of value to influence the action of the public official in the execution of contract.
- b) "Fraudulent practice" means misrepresentation of facts in order to influence the execution of the contract to the detriment of the Institute, and it includes collusive `practices among tenderers (prior to or after tender submission) designed to deprive the Institute of the benefits of free and open competition.
- c) The Institute will reject a proposal for award if it determines that the tenderer recommended for award was engaged in corrupt or fraudulent practices in competing for this contract.
- d) The Institute will declare a firm ineligible, either indefinitely or for specified period of time, for award of the contract at any time during tendering or, contract period it determines that the firm was engaged in corrupt and fraudulent practices in competing for or in executing the contract.

#### **NOTICE PERIOD FOR ABANDONMENT OF CONTRACT:-**

Either party shall be entitled to abandon the contract after serving three months notice in writing to the other party regarding abandonment of contract. However, the successful tenderer who is handling the contract shall have to continue the work even after expiry of the notice period of three months till an alternative arrangement is made by the Institute. No compensation of claim in the event of such abandonment shall be admissible to the successful tenderer.
