- 10) Transfer certificate.
- 11) Study certificate from 6th class to Intermediate.
- 12) Joint affidavit to be executed by Parent & Student on Non-Judicial stamp paper worth of Rs.20/-_
- Additional documents to be submitted if the student comes under direct NRI:
 - 13) Recent NRI status certificate of the parent issued by the respective embassy with their seal or OCI/PIO/Permanent citizenship/ residence certificate from the competent authority
 - 14) Copy of NRI bank account statement for the last 6 months.
 - 15) Employment certificate of NRI parent. In case of self-employment, nature of business, annual income and proof thereof to be furnished and copy of the income tax returns filed for the previous financial year.
