## **Online Web-based counselling :**

- i. Based on the priority of courses selected by the candidate in the online application the web-based counselling will be done.

### **The Candidates;**


- ii. can exercise options to all courses to which they are eligible. The allotment of seats will be now as per the order of priorities/options given by them in the online application.
- iii. are advised to read the regulations and prospectus carefully before exercising web options.
- iv. onetime password will be sent to the registered mobile number at the time of exercising web options after saving Options. The password consists of SIX letter code with English capital A to Z.
- v. are instructed to take a printout of saved options.
- vi. will receive the message on their registered mobile after allotment of seat. However, the candidates have to check the website frequently, after closure of date of exercising options, for allotments.
- vii. have to download the Provisional allotment letter by making online payment of Rs. 5,500/- (part of tuition fee).
- viii. have to report to the Registrar, SVIMS with copy of Provisional allotment letter with all the original certificates on the date specified in the allotment letter.
- ix. Admission order will be issued only after verification of all the requisite original certificates by the University staff, payment of balance tuition fee after deducting Rs. 5,500/- and Caution deposit. The candidate is instructed to deposit all the certificates with the University.
- x. The student has to join in the respective college with admission order before the due date mentioned.
- xi. If the candidate fails to join by the due date/ if doesn't fulfill admission criteria, the allotment / admission stands cancelled automatically.
- xii. Original certificates will not be returned to candidates unless the candidate cancel the seat and discontinues from the course.
- xiii. The candidates has to abide by the regulations for refund of fee, (refer point no. [12.1. for Cancellation & Refund of Fees](#), and [12.2. for Discontinuation, in the prospectus.](#))
- xiv. No individual communication will be sent to the candidates. Candidates are required to check the university website <https://svimstpt.ap.nic.in> from time to time for notifications regarding schedule for exercising web-options and list of allotted candidates.
- xv. In case of grievance, the decision of Director-cum-VC, SVIMS shall be final and binding-

### **2<sup>nd</sup> and 3<sup>rd</sup> counselling - Web Options Conditions are as given below:**

1. All the applicants must exercise their web options online to get the seat allotment. No seat will be allotted without exercising the web-options online for 2<sup>nd</sup> & 3<sup>rd</sup> web-counsellings.

2. The **candidates who are reported at University either Phase I or phase II and willing to go for sliding** shall be given provision for Phase-III web options submission. (Phase I or phase II allotted & reported courses will not be available for selection for sliding candidates. The sliding candidate has to select except the allotted course in Phase I or Phase II).
  - > For fresh candidates all 12 courses will be available for selection.
  - > If a candidate reported in phase I and not participated in phase II then the candidate comes under sliding and will give the course selection except Phase I course.
  - > If a candidate reported in phase II and not participated in phase I then the candidate comes under sliding and will give the course selection except Phase II course.
  - > If a candidate reported in both phase I and in Phase II then the candidate comes under sliding and will give the course selection except Phase II course.
3. The remaining all candidates including fee paid but not reported at University will be given provision to select all 12 preferences for selection in Phase III web options submission.
4. The candidates who received admission order in Phase-I and II counsellings and not reported to Principals of respective colleges will be considered as fresh candidates only during Phase III counselling.

**Note:**

- 
- a) **It is not mandatory to select all the courses, if the candidate is not interested for some courses they can choose “Not Interested” option for the courses not interested.**
  - b) **Candidates who are opting for sliding from one course to another course select the options carefully. If you are interested for one course select that course only and for remaining choose “Not Interested”**
  - c) **If new course is allotted for sliding candidate, then their old seat will be automatically cancelled and the same seat is allotted in the 2<sup>nd</sup> & 3<sup>rd</sup> web-counselling itself to another candidate.**

5. On the notified date, the web options are processed and allotment is communicated to the candidate through SMS & e-mail as well as displays at SVIMS website.
6. Candidates are instructed to be careful while exercising options on the web and take the print out of the web-options.
7. Candidates are informed to check their final allotment, take printout of allotment letter from the web, and report to the University on or before the date furnished on the allotment letter, failing which the candidate will lose the admission.

8. The candidates may note that
- Options Exercised for one phase will not be considered for other phase of Counseling.
  - Candidates have to exercise options afresh for each phase of Web based Counseling
  - In case if they are satisfied with the previous allotment, options need not be exercised again. Options may be exercised for those courses even if the vacancies are not available, as vacancies may arise due to sliding, cancellation and conversions.
9. If the candidates secure a seat in Phase-II or phase – III, he/she will lose the claim on the earlier allotted course and has to report to the new course by downloading the allotment letter on or before the date furnished in the allotment letter. Failing to report within the date furnished in the allotted course, the candidates will forfeit the claim on the new course as well as on the old course.
10. OTP verification is mandatory to submit the Phase-II or phase – III web options. OTP will be sent to the registered Mobile Number or registered e-Mail ID of the candidate.

- SSC Marks Statement
- Intermediate marks list (10+2)
- Study certificate/s (6th to Inter)
- Transfer certificate (Intermediate)
- Social status (caste) certificate (BC/SC/ST)  
(Latest relevant caste certificate mentioning sub category is compulsory)
- Other certificate/s : TTD/SVIMS/PWD/NCCCAP/EWS/ Income/Residence

**Note:** *The admission allotment was made based on the data provided by the candidate in the application. However, Admission will be confirmed on submission of relevant, latest original certificates.*



**Instructions to the candidates:**

1. The candidates are instructed to comply with all the instructions stipulated in the prospectus prior to and after admission.
2. Ragging is strictly prohibited. If any incident of ragging comes to the notice of the authorities, necessary action will be taken as per the institute/ Govt. norms. "Online undertaking affidavit" duly completed, signed by the student and parent shall be submitted on the date of joining in the O/o the Principal of the college concerned. (Source: <http://www.amanmovement.org>).
3. Joint affidavit to be executed by Parent & Student on Non-Judicial stamp paper worth of Rs.20/- (*The proforma is available in the SVIMS website*) signed by the student and parent shall be submitted on the date of joining in the O/o the Principal of the college concerned.
4. The selected candidates have to deposit all the original certificates on the day of reporting to the University for receiving Admission Order and certificates will be returned only at the time of leaving the institution. Hence, they are **advised to keep sufficient no. of Xerox copies of certificates** with them for future use.
5. There is no guarantee that all the candidates who participated / submit the Phase II web options for 2<sup>nd</sup> web-counselling will get the admission. All the seats will be filled up based on merit following the rules of reservation.
