B) Online Web-based counselling instructions :

The Candidates:

- i. Can exercise options to all courses to which they are eligible. The allotment of seats will be as per the order of priorities/options given by them in the online application.
- ii. Are advised to read the regulations and prospectus carefully before exercising web options.
- iii. Onetime password will be sent to the registered mobile number at the time of exercising web options after saving Options. The password consists of SIX letter code with English capital A to Z.
- iv. Are instructed to take a print out of saved options.
- v. Will receive the message on their registered mobile after allotment of seat. However, the candidates have to check the website frequently, after closure of date of exercising options, for allotments.
- vi. Has to download the Provisional allotment letter by paying Rs. 5,500/- which is not refundable (part of tuition fee).
- vii. Has to report to the Registrar, SVIMS with copy of Provisional allotment letter with all the original certificates on the date specified in the allotment letter.
- viii. Admission order will be issued only upon verification of all the requisite original certificates by the University staff, payment of the remaining tuition fee and Caution deposit. The candidate is instructed to deposit all the certificates with the College / University authorities.
- ix. The student has to join in the respective college with admission order before the due date mentioned.

- If the candidate fails to join by the due date/ doesn't fulfill the admission criteria, the allotment
 / admission stands cancelled automatically and the seat will be filled in the subsequent
 counselling.
- xi. Original certificates will not be returned to candidates unless the candidate cancels the seat and discontinues from the course.
- xii. For refund of fee, refer point no. 11.1. Cancellation & Refund of Fees, 11.2. Discontinuation, in the prospectus.
- xiii. No individual communication will be sent to the candidates. Candidates are required to check the university website <u>https://svimstpt.ap.nic.in</u> from time to time for notifications regarding schedule for exercising web-options and list of allotted candidates.
- xiv. In case of grievance, the decision of Director-cum-VC, SVIMS shall be final and binding.

C) Web Options and seat allotment procedure

- 1. All the applicants must exercise their web options online to get the seat allotment. No seat will be allotted without exercising the web-options online for 3rd round web-counselling.
- 2. If you are satisfied with the course allotted and admitted, during previous round counselling, they need not to participate in further rounds.
- 3. If the seat is not allotted in the 1st round & 2nd round they will have the availability of all the courses for choosing options. (12 courses)
- 4. The candidates who are reported at University during 1st or 2nd round allotted course and willing to opt for sliding shall be given provision during 3rd round web options except the seat allotted during previous round.
- 5. The candidates who received admission order from the University during 3rd round shall submit the joint affidavit & joining report to respective Principals of the colleges. Otherwise, the seat will be cancelled automatically without notice.

Note:

- a) It is not mandatory to select all the courses, if the candidate is not interested for some courses they can choose "NOT OPTING IN 3rd PHASE COUNSELLING" option for the courses not interested.
- b) Candidates who are opting for sliding from one course to another course select the options carefully. If you are interested for one course/s select that course only and for remaining options choose "NOT OPTING IN 3RD PHASE COUNSELLING"
- c) If new course is allotted for sliding candidate, then their old seat in previous round will be automatically cancelled and the same seat is allotted to another candidate.
 - 6. On the notified date, the web options are processed and allotment is communicated to the candidate through SMS & e-mail as well as displays at SVIMS website.
 - 7. Candidates are instructed to be careful while exercising options on the web and take the print out of the web-options.
 - 8. Candidates are informed to check their final allotment, take printout of allotment letter from the web, and report to the University on or before the date furnished on the allotment letter, failing which the candidate will lose the admission.

9. The candidates may note that

a) Options Exercised for one phase will not be considered for other phase of Counseling.b) Candidates have to exercise options afresh for each phase of Web based Counseling

c) In case if they are satisfied with the previous allotment, options need not be exercised again. Options may be exercised for those courses even if the vacancies are not available, as vacancies may arise due to sliding, cancellation and conversions.

- 10. If the candidates secure a seat in phase III, he/she will lose the claim on the earlier allotted course and has to report to the new course by downloading the allotment letter on or before the date furnished in the allotment letter. Failing to report within the date furnished in the allotted course, the candidates will forfeit the claim on the new course as well as on the old course.
- 11. OTP verification is mandatory to submit the phase III web options. OTP will be sent to the registered Mobile Number or registered e-Mail ID of the candidate.
- 12. Special instructions for TTD category applicants: The eligible TTD category applicants were given opportunity to exercise web-options during 1st & 2nd web-counsellings. One more opportunity will be given in this 3rd web-based counselling. If they do not opt for vacancies in their category as mentioned in the following table, they will be converted to the respective categories under SVU. This opportunity will not be offered in the 4th & final offline mode counselling.

- 3. Online Application Print
- 4. AP EAPCET 2024 Rank Card
- 5. SSC Marks Statement
- 6. Intermediate marks list (10+2)
- 7. Study certificate/s (6th to Intermediate)
- 8. Transfer certificate (Intermediate)
- 9. Social status (caste) certificate (BC/SC/ST categories)

(Latest relevant caste certificate mentioning sub category is compulsory)

- $10. \ Other \ certificate/s \ : \ (\ TTD/SVIMS/PWD/NCC/CAP/EWS/ \ Income/Residence) if \ applicable.$
- 11. The remaining tuition fee (**B**) has to be paid online to (<u>https://svims.digiicampus.com/home</u>) from their bank accounts only (through Debit Card, Credit Card, any UPI (Phonepe, Google Pay and other UPI APPS) & Net banking. Other modalities are not accepted.

Note: The admission allotment was made based on the data provided by the candidate in the application. However, Admission will be confirmed on submission of relevant, latest original certificates.

B) Instructions to the candidates for admission:

- 1. The candidates are instructed to comply with all the instructions stipulated in the prospectus prior to and after admission.

"Online undertaking affidavit" duly completed, signed by the student and parent shall be submitted on the date of joining in the O/o the Principal of the college concerned. - 3. Joint affidavit to be executed by Parent & Student on Non-Judicial stamp paper worth of Rs.20/-(*The proforma is available in the SVIMS website*) signed by the student and parent shall be submitted on the date of joining in the O/o the Principal of the college concerned.
- 4. The selected candidates have to deposit all the original certificates on the day of reporting to the University for receiving Admission Order and certificates will be returned only at the time of leaving the institution. Hence, they are advised to keep sufficient no. of Xerox copies of certificates with them for future use.
- 5. There is no guarantee that all the candidates who participated / submit the Phase III web options for 3rd web-counselling will get the admission. All the seats will be filled up based on merit following the rules of reservation.
- 6. To check the website frequently for updates.
