I. 2nd web-counselling for BPT, B.Sc. (N) & B.Sc. Allied Health Sciences (AHS) courses

A) Schedule of 2nd Web-counselling:

B) Online Web-based counselling

General instructions :

- On the notified date, the web options are processed and allotment is communicated to the candidate through SMS & e-mail.
- Candidates are instructed to be careful while exercising options on the web and take the print out of the web-options.
- Candidates are informed to check their final allotment, take printout of allotment letter from the web, and report to the University on or before the date furnished on the allotment letter, failing which the candidate will lose the admission.
- The candidates may note that
 - Options Exercised for one round of counselling will not be considered for another round of Counseling.
 - Candidates have to exercise options afresh for each phase of Web based Counseling
 - In case if they are satisfied with the previous allotment, options need not be exercised again.
 - Options may be exercised for those courses even if the vacancies are not available, as vacancies may arise due to sliding, cancellation and conversions.
- If the candidates secure a seat in 2nd counselling , he/she will lose the claim on the earlier allotted course and has to report to the new course by downloading the allotment letter on or before the date furnished in the allotment letter. Failing to report within the date furnished in the allotted course, the candidates will forfeit the claim on the new course as well as on the old course.
- OTP verification is mandatory to submit the 2nd round web options. OTP will be sent to the registered Mobile Number or registered e-Mail ID of the candidate.

C) 2nd round counselling - Web Options and seat allotment procedure

- a) All the applicants must exercise their web options online to get the seat allotment. No seat will be allotted without exercising the web-options online for 2nd round web-counselling.
- b) If you are satisfied with the course allotted and admitted, during previous round counselling, they need not to participate in further rounds.
- c) If the seat is not allotted in the 1st round, they will have the availability of all the courses for choosing options. (12 courses)
- d) The candidates who are reported at University during 1st round allotted course and willing to opt for sliding shall be given provision during 2nd round web options except the seat allotted during 1st round.
- e) The candidate can exercise options to all courses to which they are eligible. The allotment of seats will be as per the order of priorities/options given by them in the online application.
- f) The candidates are advised to read the regulations and prospectus carefully before exercising web options.
- g) Onetime password will be sent to the registered mobile number at the time of exercising web options after saving Options. The password consists of SIX letter code with English capital A to Z.
- h) The candidates are instructed to take a print out of saved options.
- i) The candidates will receive the message on their registered mobile after allotment of seat. However, the candidates have to check the website frequently, after closure of date of exercising options, for allotments.
- j) The candidates has to download the Provisional allotment letter by paying Rs. 5,500/- (part of tuition fee).
- k) The candidate has to report to the Registrar, SVIMS with copy of Provisional allotment letter with all the original certificates on the date specified in the allotment letter.
- l) Admission order will be issued only upon verification of all the requisite original certificates by the University staff, payment of the remaining tuition fee and Caution deposit. The candidate is instructed to deposit all the certificates with the College / University authorities.
- m) The student has to join in the respective college with admission order before the due date mentioned.
- n) If the candidate fails to join by the due date/ doesn't fulfill the admission criteria, the allotment / admission stands cancelled automatically and the seat will be filled in the subsequent counselling.
- o) Original certificates will not be returned to candidates unless the candidate cancels the seat and discontinues from the course.
- p) For refund of fee, refer point no. 9.4. Cancellation & Refund of Fees, 9.5. Discontinuation, in the prospectus.
- q) No individual communication will be sent to the candidates. Candidates are required to check the university website <https://svimstpt.ap.nic.in> from time to time for notifications regarding schedule for exercising web-options and list of allotted candidates.
- r) In case of grievance, the decision of Director-cum-VC, SVIMS shall be final and binding.

II. Admission guidelines for selected candidates (2nd web-counselling) for BPT, B.Sc. (N)& B.Sc. Allied Health Sciences courses 2025-26

A) The student has to attend physically for reporting for admission 09th or 10th ‘Sep-2025 and to submit the following original certificates in the following order at the verification counter:

1. Provisional Seat allotment letter 2025-26
2. University fee paid receipt for **Rs. 5,500/-**
3. Online Application Print
4. AP EAPCET- 2025 Rank Card
5. SSC Marks Statement
6. Intermediate marks list (10+2)
7. Study certificate/s (Class 6th to Intermediate)
8. Transfer certificate (Intermediate)
9. Social status (caste) certificate (BC/SC/ST categories)
10. Other certificate/s : (TTD/SVIMS/EWS/ Income/Residence) – if applicable.
11. Joint affidavit to be executed by Parent & Student on Non-Judicial stamp paper worth of Rs.20/- (*The proforma is available in the SVIMS website*) signed by the student and parent shall be submitted on the date of joining in the O/o the Principal of the college concerned.
12. **Fees payment:** The tuition fee (**B**) has to be paid online after verification of original certificates at SVIMS to the link <https://svims.digiicampus.com/home> from their bank accounts only through Debit Card, Credit Card, any UPI (Phonepe, Google Pay and other UPI APPS) or Net banking. Other modalities of payment is not accepted.

Note:

- i. It is not mandatory to select all the courses, if the candidate is not interested for some courses they can choose “NOT OPTING IN 2ND PHASE COUNSELLING” option for the courses not interested.
- ii. Candidates who are opting for sliding from one course to another course select the options carefully. If you are interested for one course/s select that course only and for remaining options choose “NOT OPTING IN 2ND PHASE COUNSELLING”
- iii. If a new course is allotted for sliding candidate, then their old seat in previous round will be automatically cancelled and the same seat is allotted to another candidate.

C) Instructions to the candidates for admission:

1. The candidates are instructed to comply with all the instructions stipulated in the prospectus prior to and after admission.
2. Ragging is strictly prohibited. If any incident of ragging comes to the notice of the authorities, necessary action will be taken as per the institute/ Govt. norms. "**Online undertaking affidavit**" duly completed, signed by the student and parent shall be submitted on the date of joining in the O/o the Principal of the college concerned. 3. The selected candidates have to deposit all the original certificates on the day of reporting to the University for receiving Admission Order and certificates will be returned only at the time of leaving the institution. Hence, they are **advised to keep sufficient no. of Xerox copies of certificates** with them for future use.
4. There is no guarantee that all the candidates who participated / submit the Phase II web options for 2nd web-counselling will get the admission. All the seats will be filled up based on merit following the rules of reservation.
5. To check the website frequently for updates.
