## ORDER:

In the G.O.1<sup>st</sup> to 4<sup>th</sup> read above, Government have issued guidelines for filling up of MBBS seats and fixation of fee in Sri Venkateswara Institute of Medical Sciences - Sri Padmavathi Medical College for Women, Tirupati.

- In the reference 5th read above, the Director-cum-Vice Chancellor, SVIMS, Tirupati has informed that it was brought to the notice of the Executive Board of SVIMS by the Principal of SVIMS - Sri Padmavathi Medical College for Women, Tirupati that no candidate has come forward to take admission under NRI quota of MBBS course for the 23 seats available for the academic year 2021-22 at a fee of Rs.36, 00,000/- per annum. And enquired that fee structure is negotiable in private colleges and opted for seat in other private colleges in Andhra Pradesh and other States of India offering NRI Seats. The issue was discussed in the Executive Board of SVIMS to fix the tuition fee upto Rs.25, 00,000/- per annum from the existing Rs.36, 00,000/- per annum to enable the students to take admissions at SVIMS-SPMCW, Tirupati under NRI category for the academic year 2021-22. It is further, the SVIMS has been brought under the fold of TTD and henceforth the fee structure for all the courses of SVIMS University including MBBS course of SVIMS-SPMCW will be decided from time to time by the Executive Board of SVIMS.
- 3) The Director-cum-Vice Chancellor, SVIMS, Tirupati has requested the Government to issue orders for re-fixation of fee upto Rs.25,00,000/- for Admissions at SVIMS- Sri Padmavathi Medical College for Women, Tirupati under NRI category for the academic year 2021-22 and also to include a clause in the Government orders that henceforth the fee structure for all the courses of SVIMS University including MBBS course of SVIMS-SPMCW will be decided from time to time by the Executive Board of SVIMS.
- 4) The Government after careful examination of the matter and in partial modification of the orders issued in the G.Os 1<sup>st</sup> to 4<sup>th</sup> read above, hereby issue the following guidelines for admission into MBBS course at SVIMS-Sri Padmavathi Medical College for Women, Tirupati in respect of filling up of NRI Quota seats:
  - 1. In paragraph 6, under item No.1, the words "annual tuition fee of Rs.36, 00,000/-" shall be substituted with "upto Rs.25,00,000/- for the academic year 2021-2022."
