ORDER: -

The Director of Health, Andhra Pradesh, Hyderabad and the Director of Medical Education, Andhra Pradesh, Hyderabad in their letters read above, have stated that, the Government issued orders in G.O.Rt.No.537, HM&FW (M1) Dept., dt.28.4.2007 and G.O.Rt.No.846, HM&FW (M2) Dept., dt.5.7.2007 in respect of certain Nursing personnel treating their study period of M.Sc. (N) at Nizam's Institute of Medical Sciences, Hyderabad / Sri Venkateswara Institute of Medical Sciences, Tirupathi, as on deputation during 2006-08. They have furnished proposals in respect of certain individuals to pass orders on their request, to treat their study period in Nizam's Institute of Medical Sciences, Hyderabad / Sri Venkateswara Institute of Medical Sciences, Tirupathi as on deputation.

2. After careful examination of the matter, the Government hereby order as detailed below: -

1. the quota for in-service Nursing Personnel admitted to M.Sc. (Nursing) Course in Nizam's Institute of Medical Sciences, Hyderabad and Sri Venkateswara Institute of Medical Sciences, Tirupathi or such other Semi-autonomous / Autonomous institutions likely to be established and where Grant-in-aid is provided by the Government shall be allowed upto 20% on par with the Government College of Nursing, Hyderabad, and the period of their study shall be treated as deputation;
 2. the period of service in the Govt. for making application to the M.Sc (Nursing) Course is enhanced from the existing (3) years to (5) years;
 3. in the event of leaving the studies during the course period or in case of failure to serve the Government for (5) years after completion of the M.Sc. (Nursing) course, the individual has to pay an amount of Rs.2,00,000/- (Rupees two lakhs only) as against the existing amount of Rs.10,000/- besides refund the amount received as salary upto the date to the Govt.;
 4. The above orders are applicable from the academic year 2007-2008 onwards to enable the Staff Nurses already joined the M.Sc (Nursing) course to be treated as on deputation under service quota.
3. This order issues with the concurrence of Finance (FR I) Department vide their U.O. No.12390/202/FR I/08 dt.23.6.2008.
