ORDER:

In the G.O 1st read above, certain guidelines were framed for admission into MBBS course in Sri Venkateswara Institute of Medical Sciences, Sri Padmavathi Medical College for Women, Tirupati. In the said G.O., it is prescribed, inter alia, that:

- 1. 85% of the seats (127) shall be filled through merit with annual tuition fee of Rs.60,000/- 15% of the seats (23) shall be filled through NRI/NRI sponsored quota through merit cum means basis with annual tuition fee of \$ 20,000.
- 2. Out of 85% of merit seats, 85% shall be filled with the eligible local candidates of the residual state of Andhra Pradesh (13 Districts) and 15% shall be filled under unreserved category.
- 2. In the letter 3rd read above, the Director-cum-Vice Chancellor, Sri Venkateswara Institute of Medical Sciences, Tirupati has reported that the University is following the guidelines issued in G.O. 1st read above. In view of Hon'ble High Court and Supreme Court judgments, the 36th Academic senate (dt: 08.10.2015) of Sri Venkateswara Institute of Medical Sciences resolved "to proceed with the admission process as per the courts direction as regional University from 2016-17 academic year onwards. Further, the senate advised to prepare the seat matrix with the help of Dr. NTR University of Health Science authorities. Accordingly, the meeting was held on 4th and 5th of December 2015 and seat matrix was prepared separately for each course.
- 3. The Director –cum- Vice Chancellor, Sri Venkateswara Institute of Medical Sciences, Tirupati, while enclosing the following Academic Senate Meeting resolutions and citing the judgments by the Hon'ble High Court in the year 2005 and 2015 and the fact that since the status of the University is neither mentioned in the Act nor included under state wide institutions in the A.P. Presidential Order, 1974, has requested for necessary orders on the following: for admitting students from 2016-17 academic year onwards for amendment to G.O.Ms.No. 120 HM&FW (C1) Dept, Dt. 23-8-2014.
 - (i) The Academic Senate discussed the developments at Hon'ble High Court & Supreme Court of India pertaining to MBBS admissions and the recent Govt. letter dt: 17/06/2015. The University will proceed with the admission process as per the courts directive and Govt. letter dt: 17/06/2015 as a regional university from 2016-17 AY onwards.
 - (ii) The Govt. of AP may be requested to take up the matter to continue as regional university or to make it a statewide university by amending the AP presidential order.

- (iii) As per the advice of the Vice Chancellor, Dr. NTR University of Health Science, a team may be sent comprising of a faculty and administrative staff of the university for preparing the seat matrix for admissions.
- 4. The Government after careful examination of the matter in the light of the judgments of Hon'ble High Court and Supreme Court as referred in the ref 2nd read above, hereby makes the following amendment to the guidelines for admission into MBBS course at Sri Venkateswara Institute of Medical Sciences, Sri Padmavathi Medical College for Women, Tirupati, issued vide G.O.Ms.No.120, HM & FW (C1) Dept., dt: 23-08-2014.

AMENDMENTS

In the said order:

- I. In paragraph 6:
 - (i) For the expression "for the academic session 2014-2015", the expression "from academic 2016-2017 onwards" shall be substituted.
 - (ii) For item 2, the following shall be substituted, namely

"Out of 85% of merit seats, 85% seats shall be reserved for the eligible local candidates of Sri Venkateswara University region and the remaining 15% seats shall be unreserved as specified in the Andhra Pradesh Educational Institutions (Regulation of Admissions) Order, 1974."

- II. Paragraph 7 shall be omitted.
- III. In paragraph 8, for guidelines (i) the following guidelines shall be substituted, namely:-
 - (i) Guidelines for 85% Merit category

Eligibility:

- (a) The women candidates shall only eligible. The candidates those who should satisfy the Local or Non-local status in Andhra Pradesh as laid down in Andhra Pradesh Education Institutions (Regulations of Admissions) Order, 1974 shall eligible. The selection will be made as per the procedure laid down in the G.O.P.No.646, dated 10.07.1979 as amended in G.O.Ms.No.42, Higher Education (EC2) Department, dated 18.05.2009 from time to time.
- (b) The local candidates shall eligible for 85% of the seats from the State comprising the districts of Anantapur, Kurnool, Chittoor, Cuddapah and Nellore belonging to Sri Venkateswara University area.
- (c) 15% Un-reserved seats shall filled with the eligible candidates governed under clause 11 of the Andhra Pradesh educational institutions (Regulation of Admissions) Order, 1974.
- (d) The candidates should fulfill the educational qualifications and age as per Medical Council of India norms.
- (e) Candidates should have qualified in A.P EAMCET and shall secure not less than 50% marks for open category 40% for BC, SC, ST candidates, 45% marks for OC-PH in the examination conducted by the competent authority.

Selection procedure:

- (f) Selection will be made based on the rank assigned by the Convener, A.P EAMCET by the committee appointed by Director-cum-Vice Chancellor, Sri Venkateswara Institute of Medical Sciences at Tirupati.
- (g) 15% of unreserved seats will be filled first, then the 85% of the local seats will be filled with the candidates of Sri Venkateswara University region.

Reservation of seats:

- (h) Selection will be made based on the rank assigned by the Convener, A.P EAMCET by the committee appointed by Director-cum-VC, SVIMS at Tirupati.
- (i) The number of seats for SC, ST and BCs shall be reserved and filled as per the reservations (i.e.) SC-15%, ST-6% and BC-29%.
- (j) In the event of non availability of candidates for the seats reserved for S.T. shall be filled with the candidates belonging to the Scheduled Castes and vice-versa.
- (k) In the event of the candidates from SC and ST are not available, these seats shall be allotted to the candidates under open competition.
- (I) The 29% of seats for BCs shall be distributed as BC-A 7%, BC-B-10%, BC-C-1%, BC-D-7% and BC-E-4%.
- (m) If qualified candidates belonging to Backward Class of particular group are not available, the left over seats shall be adjusted for the candidates of next group. If qualified candidates belonging to Backward Classes are not available to fill up the 29% seats reserved for them, the left over seats shall be treated as Open Competition seats and shall be filled up with candidates of General Pool.
- (n) The Scheduled Castes, Scheduled Tribes and Backward classes sub categories belonging to the State of Andhra Pradesh only shall be considered as specified by the Govt. of A.P from time to time.
- (o) The reservations for special categories i.e., CAP (Army)-1 %, NCC-1 %, Sports and Games-0.50%, Physically Challenged-3 %, Police Martyrs Children (PMC)-0.25% shall also be adopted on the basis of compartmentalized horizontal reservation for each category.
- 5. The Government after careful examination of the matter hereby accord permission to the Registrar, Sri Venkateswara Institute of Medical Sciences, Tirupati to take action to issue notification, prepare prospectus, seat matrix for MBBS course w.e.f 2016-17 academic year onwards duly following the procedure as is being followed by Dr. NTR University of Health Sciences in the above areas for the above mentioned courses and the rules specified in the Andhra Pradesh Educational Institutions (Regulations of Admissions) Order, 1974 applicable to Non-statewide Universities and Educational Institutions.
- 6. The Director cum Vice Chancellor, Sri Venkateswara Institute of Medical Sciences, Tirupati shall take necessary action in the matter to ensure that the provisions of Presidential Order are followed in true letter and spirit, in the conduct of admission process.
