"Pending amendment of the A.P Medical Practitioners Registration Act hereby issues the Executive instructions to release the certificates and registration of additional qualifications after successful completion of MBBS / PG / Super Specialty course, prior to Senior Resident ship "

2. In the letter 6<sup>th</sup> read above the Director-cum-VC, SVIMS, Tirupathi has requested the Government for continuation of one year compulsory service in the interest of providing patient services at SVIMS, serving the underserved population as on obligation for receiving training, as well as to meet the MCI requirements for continuation of recognition of the courses.
3. Government after careful examination hereby ordered to continue the earlier policy of one year Government compulsory service to Post Graduates (Broad / Super Specialty) at SVIMS with immediate effect and their registrations shall be done after completion of one year compulsory Government service.
4. The Director-cum-Vice Chancellor, SVIMS, Tirupathi / Director of Medical Education, Registrar, NTR UHS and Registrar, AP Medical Council shall take necessary action accordingly".
