GOVERNMENT OF ANDHRA PRADESH ABSTRACT

Medical Education – Sri Venkateswara Institute of Medical Sciences – Sri Padmavathi Medical College for Women, Tirupati – Filling up of seats in MBBS course – Certain amendments to the existing guidelines – Issued.

ORDER:

In the G.O. 1st read above, certain guidelines were framed for admission into MBBS course in Sri Venkateswara Institute of Medical Sciences – Sri Padmavathi Medical College for Women, Tirupati and subsequently, the Director cum VC, SVIMS has proposed certain modifications, and accordingly issued in the G.O.2nd read above.

- 2) In the letter 3rd read above, the Director cum VC, SVIMS, Tirupati has stated that Government of Andhra Pradesh has joined in All India Quota by contributing 15% of total seats in Under Graduation Medical Course and permission to the Dr. NTR University of Health Sciences, Vijayawada to conduct common counseling as per MCI Rules, fill up the MBBS seats in SVIMS, Sri Padmavathi Medical College for Women, Tirupati.
- 3) The Government after careful examination of the matter, hereby makes the following amendment to the guidelines for admission into MBBS course at Sri Venkateswara Institute of Medical Sciences Sri Padmavati Medical College for Women, Tirupati issued vide G.O.Ms.No.120, HM&FW (C1) Deptt., Dt.23.8.2014 and subsequently amended in G.O.Ms.No.24, HM&FW (C1) Deptt., Dt.22.3.2016.

AMENDMENTS

In the said order:

- 1. For the expression "EAMCET", the expression "NEET-UG" shall be substituted.
- 2. In paragraph 6, for item No.1, the following substituted, namely;
 - a) The Government of Andhra Pradesh has decided to join in All India Quota by contributing 15% of total seats in Under Graduate Medical Course.
 - b) Out of total intake of seats, 15% seats shall be surrendered to All India Quota, 15% of the seats shall be filled through NRI/NRI sponsored quota through merit in NEET. Remaining 70% seats shall be filled through merit category in NEET.
 - c) The annual tuition fee of Rs.60,000/- to be collected from the students admitted under All India Quota and State Merit category. Similarly, the annual tuition fee of US\$20,000 to be collected from the students admitted under NRI / NRI sponsored category for 5 years.

3. In paragraph 6, for item No.2, the following substituted namely:

"The 70% of Merit seats shall be filled by following Local and Un-reserved Quota as specified in the AP Education Institutions (Regulation of Admissions) Order, 1974 as subsequently amended, subject to following the Rule of Reservations.

4. In paragraph 7, the following substituted namely:

"In view of Common Counselling as per MCI Rules, the Registrar, Dr. NTRUHS, Vijayawada shall fill all the seats through the counselling and allot the candidates to SVIMS-Sri Padmavathi Medical College for Women, Tirupati".

5. In paragraph -8, for the item (i) of guidelines, shall be substituted namely:

"The 70% of seats { after excluding seats surrendered to All India Quota (15%) and NRI Category (15%)} shall be filled with the same Presidential Orders being followed in filling the seats in Government Medical Colleges as Non State Wide Institution (i.e. 85% of seats to be filled with local eligible candidates and 15% seats shall be un-reserved) and reservations i.e. SC, ST, BC, Special categories reservations to be implemented."

The Committed constituted by the Competent Authority i.e. the Vice Chancellor of Dr. NTRUHS, Vijayawada shall make selections.

- 6. In paragraph-8, for the item of guidelines a,b,c,d,e under item ii, the following shall be substituted namely:
 - 8(ii) The following are the admission regulations applicable to MBBS course under NRI / NRI sponsored category of SVIMS, Sri Padmavathi Medical College for Women, Tirupati.
 - a. Dr. NTR University of Health Sciences shall notify for MBBS admissions under NRI / NRI sponsored category for the seats available at SVIMS, Sri Padmavati Medical College for Women. A Committee will be constituted by the Vice Chanellor of Dr. NTRUHS for admission into NRI and NRI sponsor categories.
 - b. Nationality and Domicile: The candidate should be Indian National or Person of India Origin (PIO) / Overseas Citizen of India (OCI) Card Holder. She should be from AP origin.
 - c. NRI Category: the candidates who are claiming under NRI category shall satisfy the following:
 - (i) Applicant shall be the ward of NRI or NRI citizen by herself.
 - (ii) The NRI parent shall submit the following documents:
 - a. NRI status certificate issued by respective embassy /OCI /PIO / Permanent citizenship status.
 - b. Copy of recent NRI bank account details.
 - Employment certificate of NRI parent. In case of self employment, nature of business, annual income and proof thereof.

d. NRI Sponsored Category:

- (i) In the event of non-availability of adequate number of eligible NRI candidates, NRI sponsored candidates will be considered subject to fulfillment of the following:
- (ii) The sponsor shall be blood relation to the applicant. i.e. father, mother, brother or their children, sister or their children, maternal uncle or his children, maternal aunt or her children, paternal uncle or his children, paternal uncle or his children, paternal grandfather, maternal grandfather, maternal grandmother, paternal grandfather and paternal grandmother.

(iii) The genealogical tree certificate or equivalent issued by the Tahsildar and above cadre, for establishing the relationship of the sponsor with valid visa, copy of the recent NRI bank account details and Employment Certificate.

e. Method of Selection:

- (i) A separate merit list will be prepared for NRI and NRI sponsored category basing on the rank secured in the NEET examination.
- (ii) After all the NEET qualified and eligible candidates under NRI category gets admitted, the remaining vacancies shall be filled with NRI sponsored category.
- f. The Vice Chancellor, Dr. NTR University of Health Sciences, Vijayawada is the Competent Authority in respect of making admissions into all the seats (except seats surrendered to All India Quota) in SVIMS- Sri Padmavathi Medical College for Women, Tirupati.
- 7. The Director cum Vice Chancellor, Sri Venkateswara Institute of Medical Sciences, Tirupati shall take necessary action in the matter to ensure that the provisions of Presidential Order are followed in true letter of spirit, in the conduct of admission process.
