I am directed to state that the Board of Governors considered the Assessment Report (12.08.2019) on the standard of examination and other teaching facilities available at Sri Venkateswara Institute of Medical Sciences, Tirupati for purpose of Renewal of recognition of DM(Oncology) qualification for 02 seats granted by Sri Venkateswara Institute of Medical Sciences (Deemed University), Tirupati and decided as under: -

"The Board of Governors considered the Council Assessor's Report (12.08.2019) together with the recommendations of the PG Expert Group (BoG) and decided to recommend to the Central Government that renewal of recognition of DM(Oncology) qualification for 02 seats granted by Sri Venkateswara Institute of Medical Sciences (Deemed University), Tirupati in respect of students being trained at Sri Venkateswara Institute of Medical Sciences, Tirupati be renewed.

The Board of Governors further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
