I am directed to state that the Postgraduate Medical Education Committee of this Council at its meeting held on 07/09/2017 considered the Council Assessor's Report (30.06.2017) on the standard of examination and other teaching facilities for Recognition of MD(Nuclear Medicine) qualification for 02 seats at Sri Venkateswara Institute of Medical Sciences, Tirupati granted by Sri Venkateswara Institute of Medical Sciences (Deemed University), Tirupati and decided as under:-

"The Postgraduate Medical Education Committee considered the Council Assessor's Report (30.06.2017) and decided to recommend to the Central Government that MD(Nuclear Medicine) qualification for 02 seats granted by Sri Venkateswara Institute of Medical Sciences (Deemed University), Tirupati in respect of students being trained at Sri Venkateswara Institute of Medical Sciences, Tirupati be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition.
