"The Board of Governors considered the Council Assessor's Report (07.08.2019) together with the recommendations of the PG Expert Group (BoG) and decided to recommend to the Central Government that renewal of recognition of M.Ch(Surgical Oncology) qualification for 02 seats granted by Sri Venkateswara Institute of Medical Sciences (Deemed University), Tirupati in respect of students being trained at Sri Venkateswara Institute of Medical Sciences, Tirupati be renewed.

The Board of Governors further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition.
