- 2. Candidates should attend the interview at their own cost.
- 3. Interim enquiries will not be entertained.
- 4. The maximum age limit for Research Associate is less than 35 years as on the date of interview.
- 5. Candidates who fail to bring the original certificates at the time of joining and if any discrepancy is found in the documents will not be allowed to join the selected contract post and the position will be offered to the waiting list candidates.

- 6. The Principal Investigator and/ or appointing authority reserve the right to terminate the service of the contract personnel even during the agreed contract period or extended contract period without assigning any reason. Leave shall be as per Institutional policy for contract staff.
- 7. The Director-cum-Vice-Chancellor, SVIMS, reserves the right to cancel / modify the recruitment process at any time, during the process, at their discretion.
- 8. The decision of the Director, SVIMS will be final and binding.

Terms and Conditions for Appointment:

A). Job Description:

The selected candidates are responsible for collection of data mentioned in the printed form and online core proforma of HBSR at admission and subsequent follow up at 1 month and 3 months after the onset of stroke and regular data transmission on day-to- day basis. They should maintain hard copies of the HBSR core proforma and register of the all patients; They should assist the Principal Investigator (PI) in the monthly review meeting and to provide any clarifications sought by ICMR –NCDIR. Participate in the trainings and workshops conducted by the ICMR-NCDIR. Participate in the quality check by addressing the queries and issues raised by the ICMR-NCDIR. They should assist the PI in the preparation of progress report of the project work and Statement of Expenditure and Utilisation Certificate to be submitted to ICMR-NCDIR at regular intervals. They should facilitate the PI/representatives during monitoring, supervision and quality assurance of collected data.
