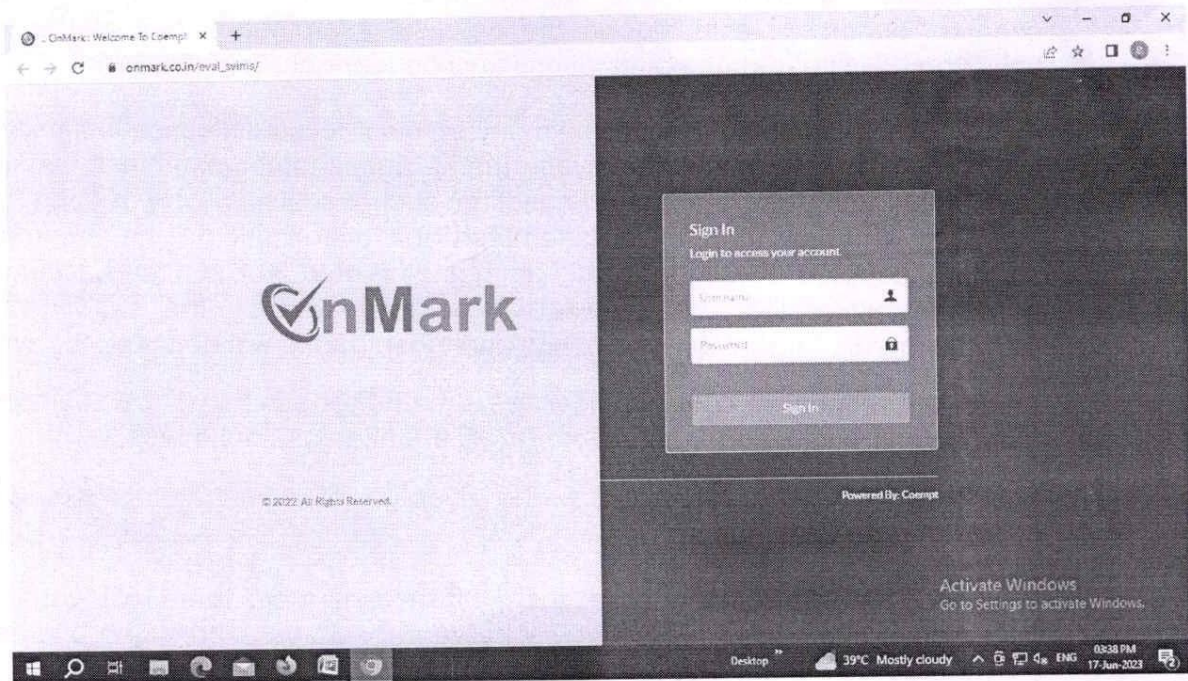
#### 1. Digital Evaluation Service

- Computer based Digital Evaluation service for complete pre & post evaluation process – implemented with effect from 2020 onwards
- Digital Evaluation system is flexible to students and administration
- It reduces high cost, man power, time etc spent on manual process
- It avoids tampering, misuse, fraudulent use and reduces the chance of bias-based evaluation.
- Examiners prefer online evaluation and found safe during COVID pandemic

#### Process :

1. The institute has introduced Digital valuation from the year 2020 onwards . After examination, the unique barcode answer booklets collected from the Chief Superintendent at examination hall will be subjected for scanning.
2. On receiving the user ids and passwords from the IT people, the link for evaluation of answer scripts along with user id and pass word will be shared to the examiners (both external and internal examiners).
3. The examiners evaluate the theory paper before attending to practical examination or will evaluate on the practical examination day at the Digital valuation hall situated at examinations section (central library building), SVIMS.
4. After valuation by all the examiners, in any scripts if found difference in marking 'not attempted' i.e., one examiner gives marks and another examiner marked as "not attempted" for the same question such scripts will be resend to the examiner who has marked "not attempted" for reverification. If he confirms that as "not attempted" it will be treated as 'not attempted' and proceed accordingly. If student attempted, the answer will be evaluated by the examiners and provides marks for that question only, and these marks will be taken for average
5. As per the respective course guidelines, the answer scripts will be subjected for four/two/one evaluations. The average will be taken as final marks.
6. Wherever 4 valutors are there, the average of 4 valuator marks will be considered as final marks.
7. Wherever the two valuations are there, if there is more than 15% variation in total marks allotment, the script will be sent for 3<sup>rd</sup> valuation. The average of, 3<sup>rd</sup> valuator marks and the marks nearest to 3<sup>rd</sup> valuator marks (either 1<sup>st</sup> or 2<sup>nd</sup> valuator marks) will be considered as final marks.
8. The MCQs OMR scripts (MBBS) shall be evaluated through OMR Scanning software at exam section under the supervision of an observer (examiner) posted for the purpose.
9. The practical/clinical and viva marks statements receive manually from the internal examiner cum HOD concerned after the examination.

10. After digital valuation of theory answer scripts, marks will be sent barcode number wise, by the IT person in the requisite format
  11. On receiving the marks, barcode numbers will be decoded and compilation of theory marks, MCQs marks (if present), practical/clinical and viva marks will be done.
  12. Grace marks will be awarded to the UG courses as per the respective course guidelines. There is no grace marks for PG courses.
  13. Final verification of compiled marks and allotment division of will be carried out at examinations section.
  14. After verification of marks, the final master copy of the marks statement will be circulated to the respective committee members for approval.
  15. After approval by the committee members, the results will be notified and communicated to the concerned Principal/ HOD and will be displayed in notice boards.
  16. The students intend to apply for re totaling can apply within 1 week of the date of results announcement. There is no revaluation of the script as per the university guidelines.



2. **Online Fee payment :**

The examination fee is paid by the student through "student software" by selecting "Payment mode" or "State Bank Collect" and the e-receipt is generated.

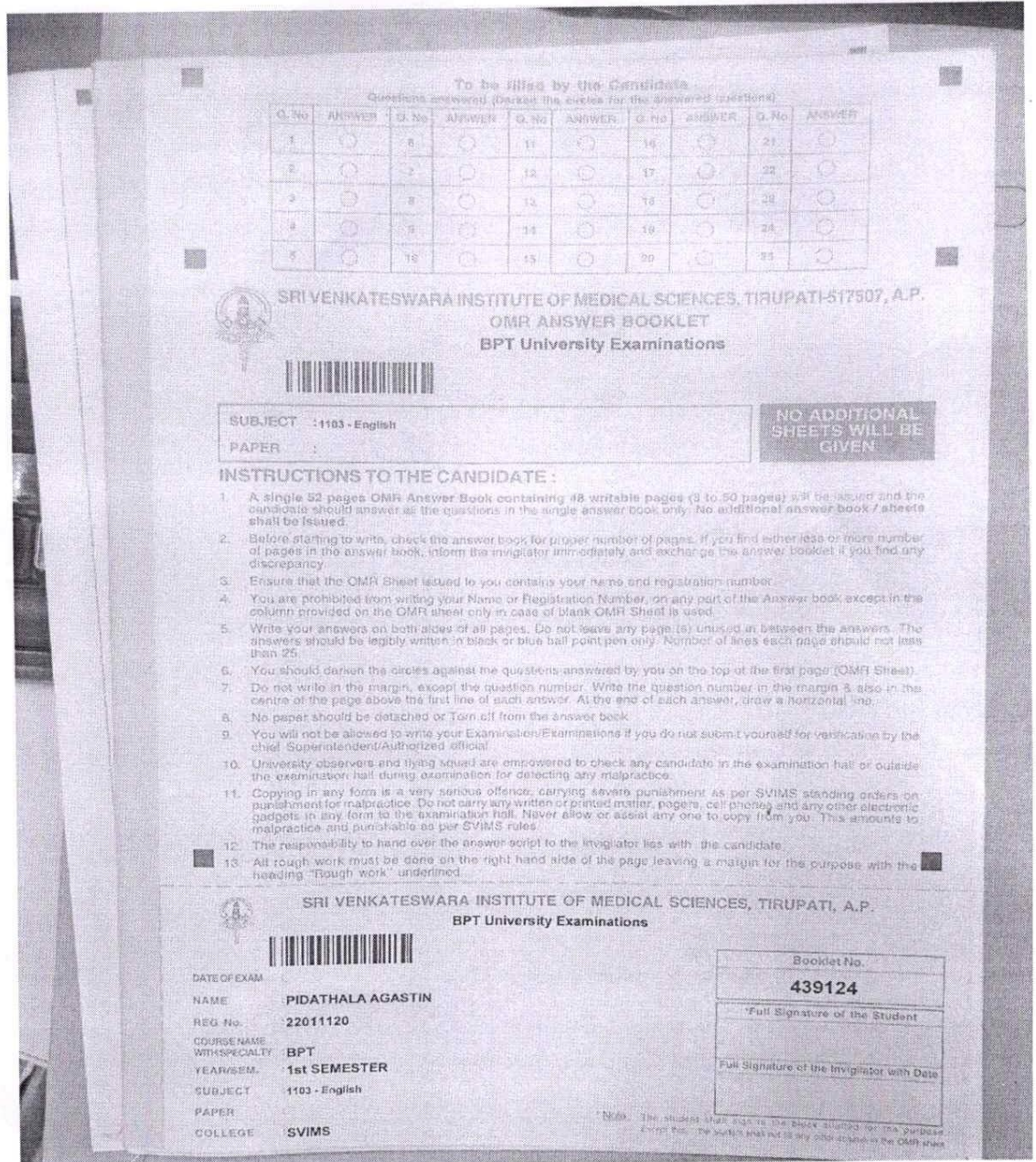

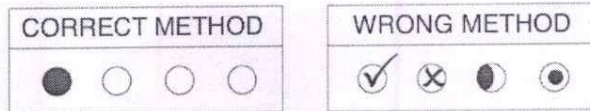

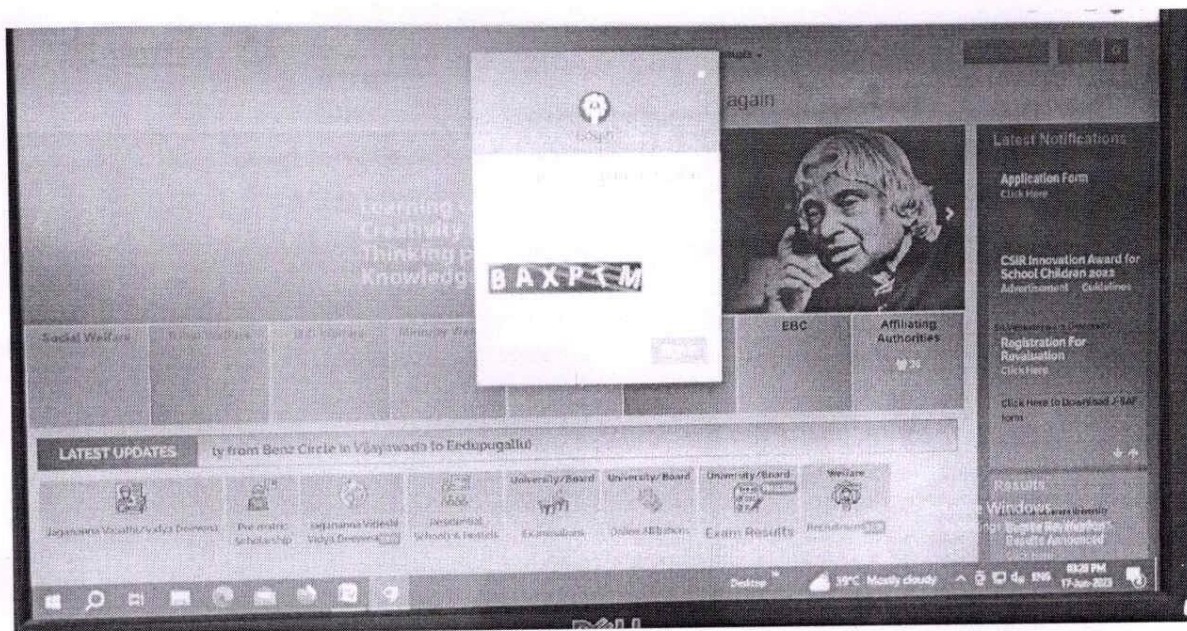
- 5. The institute is on its way to digitalize the degree certificates of all courses and also sharing the marks data of all students in the web portal developed by Andhra Pradesh State Government.

**Sharing of Marks Data in “JNANABHUMI” Portal:**

The Government of Andhra Pradesh has launched a smart Web portal named “Jnanabhumi” in 2017 for integrated delivery of services relating to Education and Scholarships. It is mandatory for all academic institutions to onboard/ implement the modules/services in “Jnanabhumi”.

As per the Government orders, all the educational institutions have to upload the academic performance record of all the students in the “students Academic Service of the institution module”.

Accordingly, SVIMS university also uploading the marks data of the students of all courses in the web portal service module w.e.f.2017-18, immediately after declaration of results of semester/end of academic year to facilitate the release of scholarships by the Social Welfare Department, Government, of Andhra Pradesh.



**6. National Academic Depository (NAD):**

NAD is an online store house of Academic awards (degree/diploma/certificates etc) lodged by the Academic Institutions in a digital format. As per the UGC guidelines the SVIMS has entered in Service Level Agreement (SLA) with NSDL, one of the Depositories for on boarding on NAD. A separate NAD cell was set up with COE as Nodal Officer. The digitalization of Convocation degrees pertaining to 2017 was completed and the digitalization of 2018 Certificates is under process. *Now the information under NAD is to be uploaded in Digilocker.*
