



- Promotion and Publicity: the parties agreed to work together to promote sports activities through various channels, including college/institute/ University website, newsletters, social media platforms, and local media, to encourage maximum students participation.
- 6. Liability and Insurance: The sports institute shall maintain appropriate insurance coverage for its facilities and sports activities. Students participating in sports and games shall be required to sign appropriate liability waivers and comply with safety guidelines.
- 7. Financial Arrangements: the financial responsibilities associated with organizing sports activities, including costs related to facilities, equipment, and coaching, shall be mutually agreed upon by both parties in writing prior to the commencement of each activity. The amount arrived with the consensus of both the parties shall be in force for a period of 3 years.
