



3. MEMBERSHIP

Any person, persons of the belonging to both sex, and is also interested in the aims and objectives of this Association who is willing to abide by the Rules and Regulations of the Association shall alone be the membership, if his general conduct and character are appeared to be good.

Members should pay subscription regularly, If any member becomes defaulter a) he is liable to lose membership and power of voting and membership could be

restored to any person put in request letter to the President.

The office bearers and other members of the governing body shall be elected b) by the general body of the Association and shall have to hold office for a period of 2 years and may continue to be in office till the new committee of the Governing Body is elected and assume office on the 1st day of March.

4. EXPULSION OF MEMBERS:

The Association reserves the right to expel any member in case any person or persons acts in contravention of the objects of the Association or its activities and also to the interests of Association or made only by a resolution passed at the General body meeting of the Association specially called for the purpose, by the majority of votes of at least 3/4th of the total number of present at the meeting, whichever is higher.

5. PRIVILEGES OF MEMBERS:

Every member shall be entitled.

1) To attend, participate and vote at any General Body meeting.

2) To vote at any election held by the Association and

3) To attend stand for election as an office-bearer or as a member of committee or as a delegate to the Association.

6. MEMBERSHIP FEE AND ANNUAL SUBSCRIPTION:

10. MANAGEMENT OR EXECUTIVE COMMITTEE:

The management of the affairs of the Association shall subject to the rules and regulations be vested in the Governing body or the Executive Committee consisting of the following types of members and they will have to work united under the guidance of the President.

- i. President.
- ii. Vice President
- iii. Secretary
- iv. Joint Secretary
- v. Treasurer
- vi. Executive Committee Members

11. MEETING OF THE ASSOCIATION:


- a) The Executive Committee shall meet atleast once in every month if possible or atleast without fail in every three months. These meetings are generally called as ordinary meetings of the committee. General body will be held in "APRIL" of every year.
- b) The office bearers who fail to attend the meeting continuously for 3 (three) months consecutive meetings are automatically deemed to be removed as office bearers. The quorum for the meeting is $2/3^{\rm rd}$ of the General Board Body.
- c) The Minutes of the meeting of the Executive Committee will be recorded in a minutes book by the Secretary of the Association.
- d) The office bearers and other members of the governing body shall be elected by the general body of the Association and shall have to hold office for a period of 2 years.

12. FUNCTIONS OF THE EXECUTIVE BODY AND OFFICE BEARERS:

a. PRESIDENT

The President shall be elected by the General Body.

- The President shall be solemnly responsible for the overall administration of the Association for making representations to the Government or concerned officials if needed. He/She is empowered to allot duties to the Executive Committee members.
- ii) The President shall be empowered to convene meeting of the Association or Executive Committee at any time if he/she feels necessary in consultation with the Secretary.
- The President is empowered to appoint any office bearers temporarily if any vacant that he has fallen vacant on account of the resignation or otherwise by co-option of the Executive Committee.



b. VICE PRESIDENT:

The Vice President shall be elected by the General body.

The Vice-President shall be elected by the General Body. He/she should assist the President in all matters connected with the association. In the absence of the President, the Vice-President, shall discharge the duties of the President.

c. SECRETARY

The Secretary shall be elected by the General body.

- v) He/She shall carry out the rules, by laws and resolutions of the Association and of the committee.

d. JOINT SECRETARY:


The Joint Secretary shall be elected by the General body.

e. TREASURER:

The Treasurer shall be elected by the General Body.

- i) He/She is empowered to collect subscription or funds from the members by maintaining accounts up to date.


16. WINDING UP:

24. PROPERTIES OF THE SOCIETY/ASSOCIATION

The Bank Account shall be operated jointly by the President and the Secretary or by the President and Treasure or by the secretary and the Treasurer i.e., by any two members among the office bearers.i.e. President, Secretary and Treasurer of the society.



1. NAME OF THE ASSOCIATION

3. MEMBERSHIP

Any person, persons of the belonging to both sex, and is also interested in the aims and objectives of this Association who is willing to abide by the Rules and Regulations of the Association shall alone be the membership, if his general conduct and character are appeared to be good.
